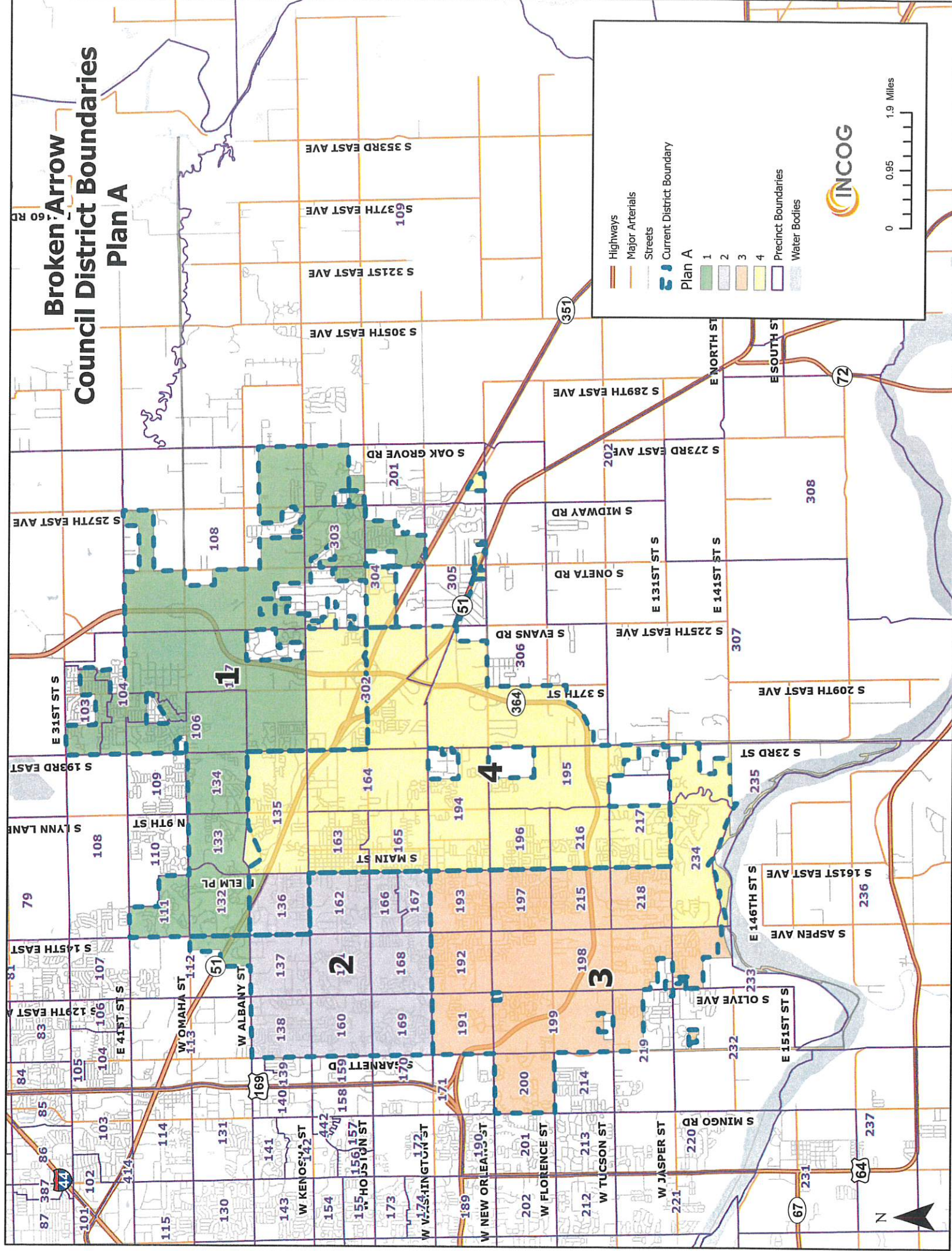

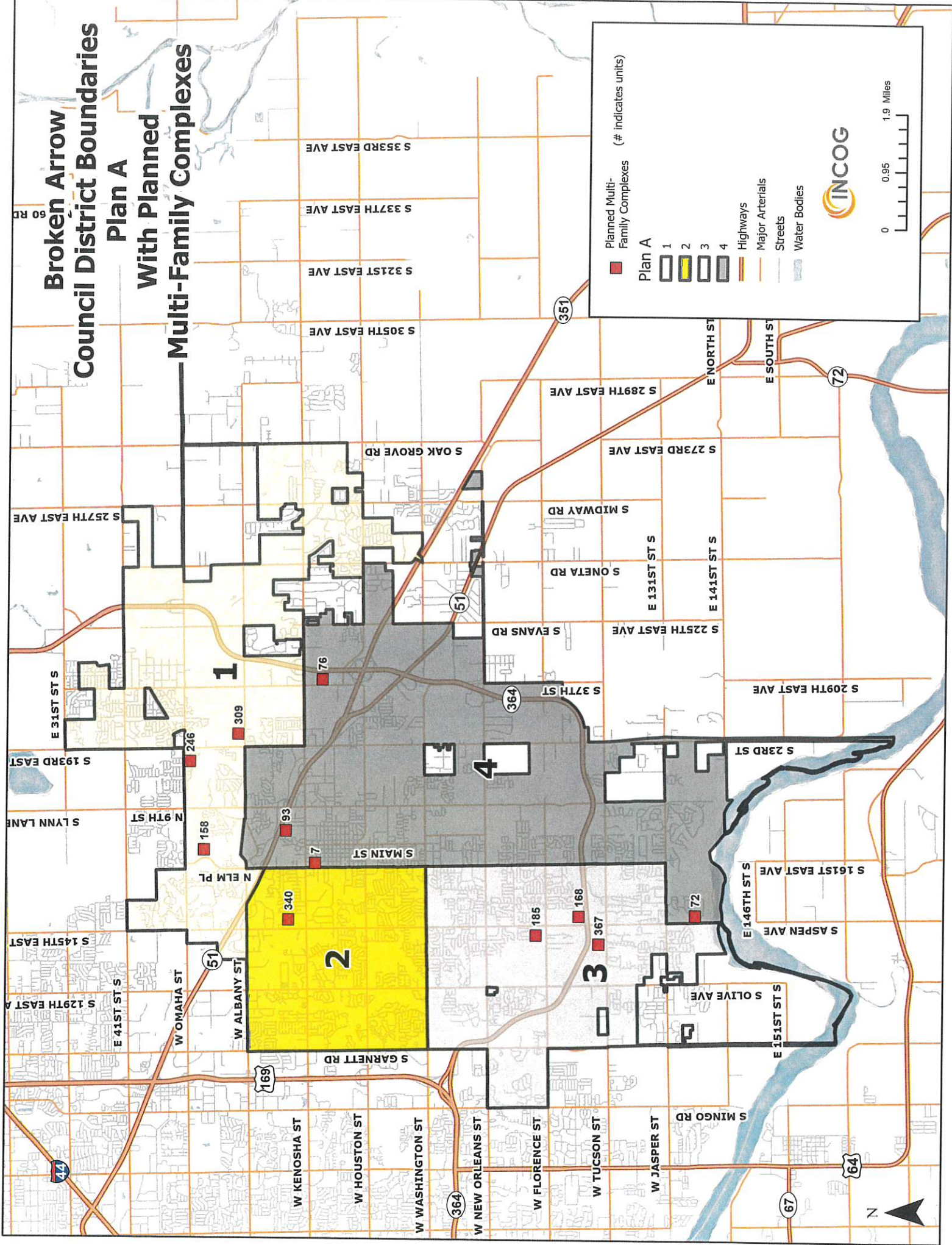

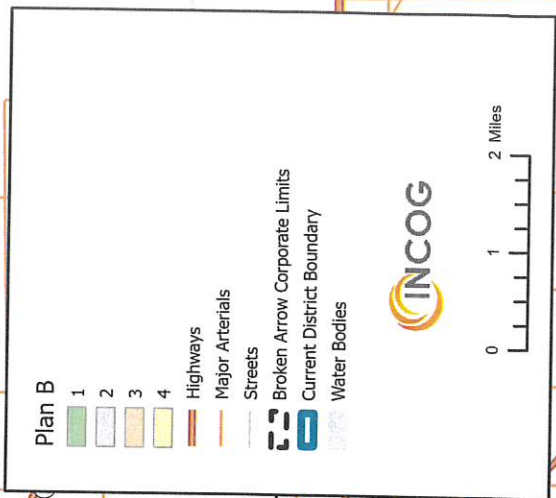

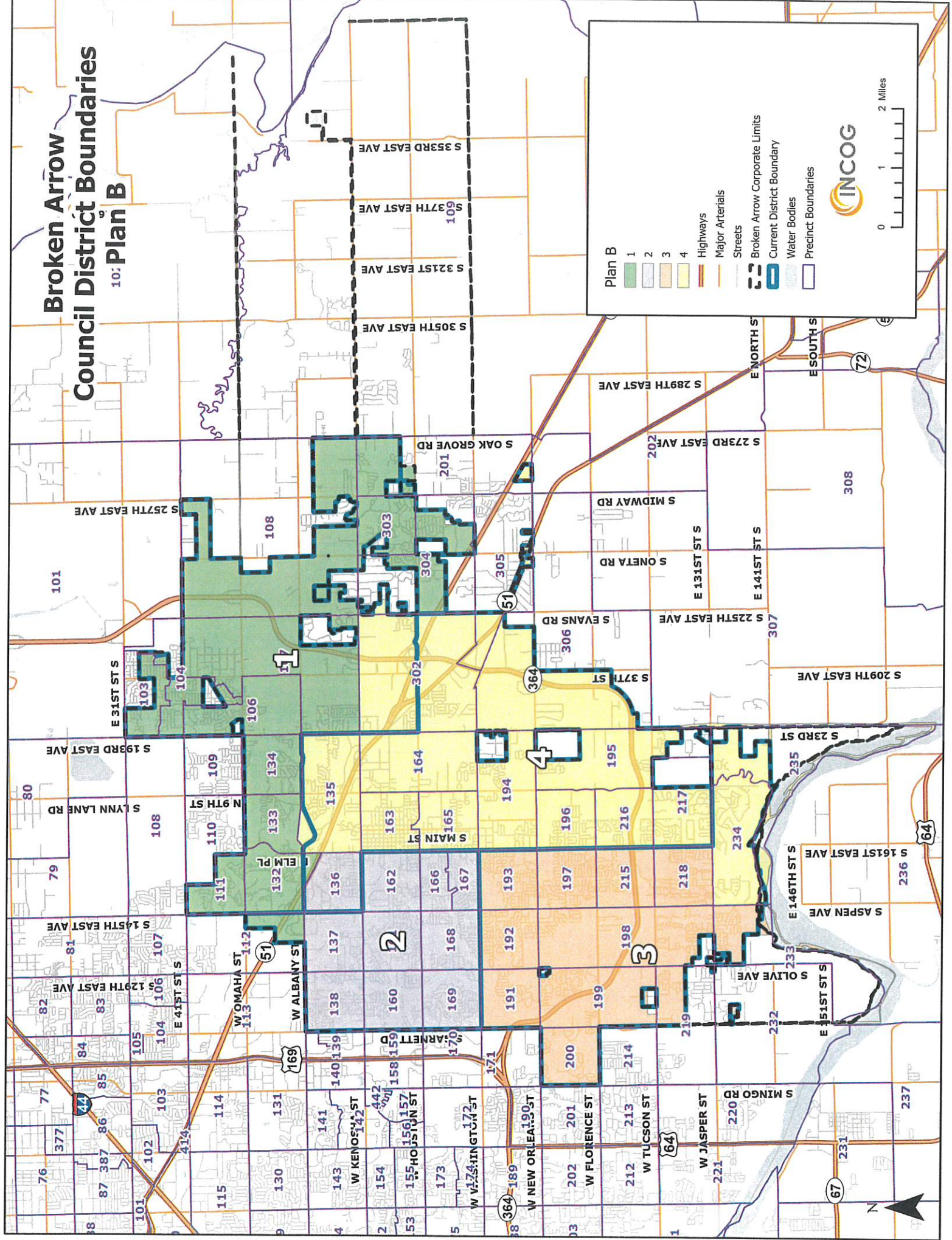
With Planned Multi-Family Complexes

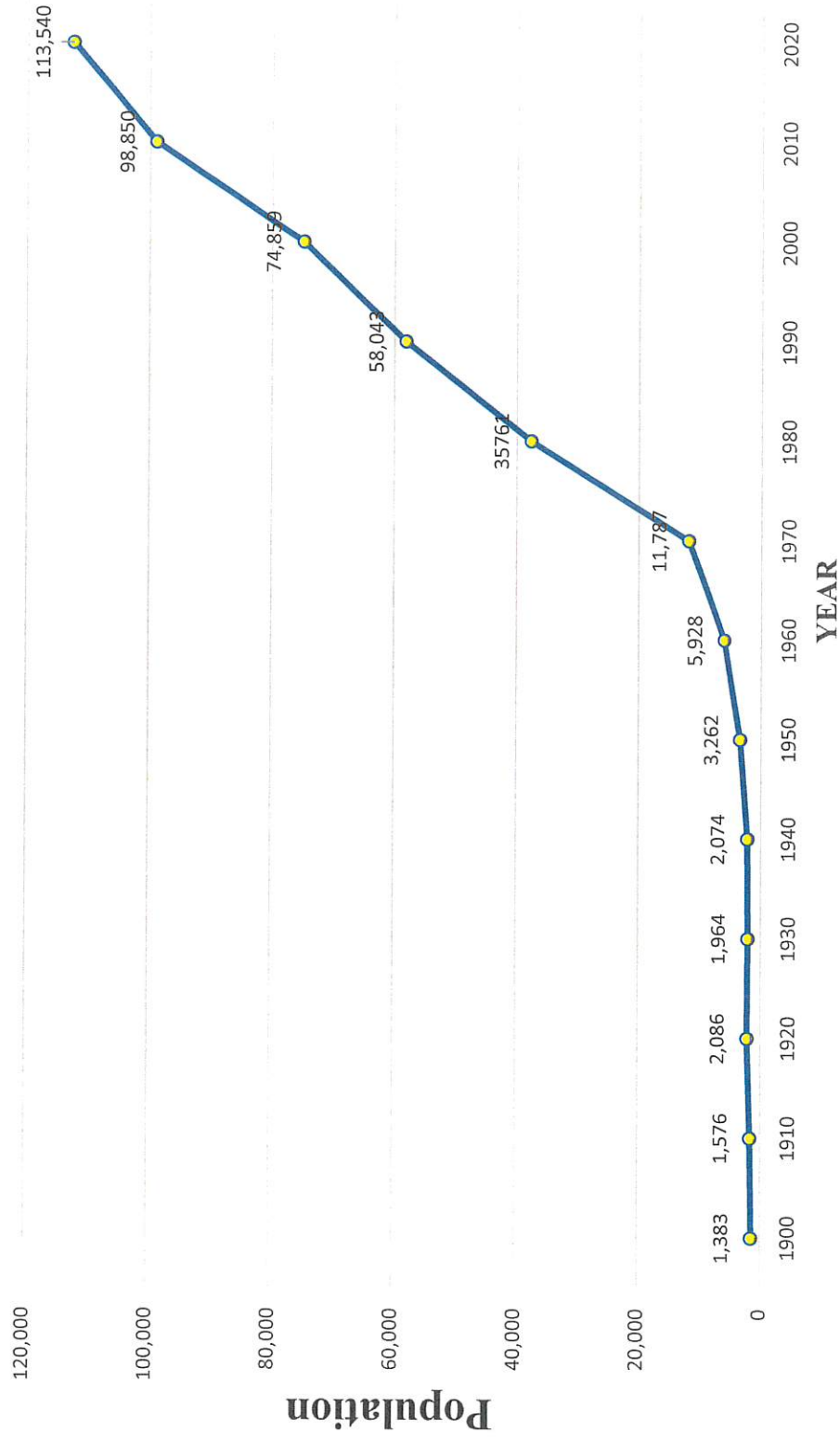
