8. _____ Delete the square footage and acreage under "Lot 1, Block 1" since it has been updated.
9. _____ Remove the portion of the 40-foot building line setback that is located in the Detention Easement next to State Highway 51.
10. _____ Vacation of Lot 9, Block 2, Prairie Dale shall be submitted to and approved by the City Council.
11. _____ Sheet 1: Provide reference to a known point to locate "Site Benchmark Square Cut in Concrete, El. 713.55" on east side of project."
