### 2017 MY Super Duty – Price Protection, Extensions and Rollovers

Since the 2017 MY Super Duty is an all new vehicle, Government Sales will not be able to price protect, extend or rollover most 2016 MY contracts. We will, however, be open to negotiating with existing customers to see if we can retain the contracts without rebidding for 2017 MY (i.e., see if customer is willing to accept a price increase). In addition, if the bid date and order submissions for the 2016 MY Super Duty occur before the final order due date and Ford Motor Company is unable to build the vehicles they will be price protected for 2017 MY.

Below is listed some of the key dates as we transition from the 2016 MY to 2017 MY Super Duty. The final order due date is currently planned for 4/1/16. We are assuming the date may get pulled ahead due to a surge of orders so please get your orders in as soon as possible to ensure you can meet demand while the new Super Duty ramps up in production.
