- Provide Firehouse Subs Public Safety Foundation with copies of paid invoices verifying City of Broken Arrow Police Department payables to the vendor(s) as per the submitted quote(s) in the application.
- Provide Firehouse Subs Public Safety Foundation with all SIGNED packing slips confirming receipt of equipment
- The check will be remitted to the organization name as stated in this memo of understanding and **must** match the EIN number submitted on the grant request. If there is a change in either information, you must submit a W-9
- In the event that the purchased equipment costs less than the dollar amount awarded, all excess funds must be returned to Firehouse Subs Public Safety Foundation If purchases exceed funding, <u>City of Broken Arrow Police Department</u> is responsible for the additional amount
- **VERY IMPORTANT:** Deadline for submitted documentation is March 31, 2017.
