RESOLUTION NO. 963

A RESOLUTION AUTHORIZING THE CITY ATTORNEY TO AGREE TO ENTRY OF JUDGMENT WITHOUT ADMITTING LIABILITY IN THE MATTER OF DAVID AND CHRISTINA VRANESEVICH AND DIRECTING THE CITY ATTORNEY TO PREPARE AND FILE THE NECESSARY DOCUMENTS TO EFFECTUATE SETTLEMENT INCLUDING A JOURNAL ENTRY OF JUDGMENT INCORPORATING THE RESOLUTION OF THE COURT'S APPROVAL PURSUANT TO 51 O.S. § 158.

WHEREAS, the Plaintiff's David and Christina Vranesevich have filed their tort claims with the City of Broken Arrow relating to an automobile accident with City Employee Bryce Campbell on the 6th day of September, 2015; and

WHEREAS, the Council has determined that settlement in this matter is in the best interest of the City of Broken Arrow in the sum of \$27,500.00 for David Vranesevich and his attorney, Joseph Bufogle, Sr. and \$16,500.00 for Christina Vranesevich and her attorney, Joseph Bufogle, Sr. which settlement includes all damages, costs, attorney fees, lost wages, past, present and future medical bills and treatment; and

WHEREAS, the City of Broken Arrow City Council has determined that such Resolution is a just and reasonable settlement; and

WHEREAS, it is the desire of the Council to approve such settlement agreement by authorizing the City Attorney to prepare and file all necessary documents to settle this case, including a Journal Entry of Judgment, which is not to admit liability, but does represent a compromised settlement of the disputed claims.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BROKEN ARROW, THAT:

- 1. The City Attorney is hereby directed to agree to an entry of judgment without admitting liability with David and Christina Vranesevich and their attorney, Joseph Bufogle, Sr.
- 2. The City of Broken Arrow is hereby authorized to settle these claims with David Vranesevich and his attorney Joseph Bufogle, Sr. receiving a total of \$27,500.00 and Christina Vranesevich and her attorney Joseph Bufogle, Sr. receiving a total of \$16,500.00.
- 3. The City Attorney is directed to file all necessary documents, including a Journal Entry of Judgment, incorporating the terms of the settlement agreement in the above amounts and to execute any and all necessary documents to effectuate this settlement for the Court's approval pursuant to 51 O.S. § 158.
