A. [17-1727](#) **Public hearing, consideration, and possible action regarding PUD-237A, Hardesty Center for Dance Education, 3.94 acres, CG, east of the southeast corner of New Orleans and Aspen Avenue**

Brent Murphy presented PUD-237A, noting the location being east of the southeast corner of New Orleans Street and Aspen Avenue. City Council previously approved Ordinance 3397 to change the zoning on this property to CG/PUD-237. He said there are two off-premise advertising signs in close proximity to this property. The applicant is requesting the statement about this signage be deleted.

Mr. Murphy said based upon the Comprehensive Plan, the location of the property and surrounding land uses, Staff recommended PUD-237A be approved as presented. Since the property has already been platted, Staff recommended that platting be waived.

Andrew Shank, Eller and Detrich, P.C., 2727 E 21st Street, Suite 200, Tulsa, OK, representing the owners, said he was in agreement with Staff recommendations. He said the existing signs will allow for continued revenue for the non-profit organization.

The Public Hearing for PUD-237A was opened. No one requested to speak. The Public Hearing was then closed.
