Deputy Chief of Police Brandon Berryhill thanked Police Department volunteers, pointing out that their service behind the scenes played a vital role. He indicated those present in the audience and made reference to a check representing the monetary value of their labor to the City. He invited Ms. Ford and her team of volunteers to step forward.

Mayor Thurmond thanked the volunteers, observing that the hours they donated did so much for the City. An enlarged facsimile of a check in the amount of \$512,629.87 was displayed. The volunteers received a round of applause and photos of them alongside Mayor Thurmond holding the check were taken.

**Presentation by Alex Mills, P.E., CFM, Director of Engineering and Construction, regarding various projects of the Engineering and Construction Department and answer questions presented by the City Council**

Engineering/Construction Director Alex Mills provided an overview of his Department, reporting also on some current projects. He reported that there were over 120 projects in planning, design or construction and explained that the Department was divided into 4 divisions of 22 employees, comprising Construction, Engineering, Planning and Stormwater Divisions. An organizational chart was displayed illustrating Mr. Mills’ observation that it was amazing how a few highly qualified Managers, along with a small group talented staff, were accomplishing so many projects.

Mr. Mills went over the responsibilities of each of the four Divisions. The job of the Construction Division was to supervise construction administration of all public improvements with regard to public and private projects. Bridge and retaining wall inspections were conducted yearly and the Division was responsible for overseeing a dam safety program, as well. The Engineering Division managed all architectural and engineering contracted projects, while performing a large number of projects in-house, also, such as mill and overlay of roads, saving the City a substantial amount of money. In

addition, Engineering handled bidding of all construction contracts, including advertisement, bid opening, tabulation and recommendations for award. Contracting and managing all professional service contracts, with respect to surveying, geotechnical and environmental services, was the domain of Division also. The Department's Planning Division handled, as Mr. Mills explained, formulation of City's Capital Improvement Plan, preparing grant and loan applications, including Surface Transportation Program (STP) grants, Community Development Block Grants (CDBG), Congestion Mitigation and Air Quality Improvement (CMAQ) grants, TIGER Discretionary Grants (Transportation Investment Generating Economic Recovery), and Oklahoma Water Resources Board (OWRB) loans. Finally, it was responsibility of the Planning Division to oversee the right-of-way acquisition process, Graphic Information System (GIS), Americans with Disabilities Act (ADA) Transition Plan, and Broken Arrow's public schools with reference to the Safe Schools Program. Turning to the Stormwater Division, Mr. Mills explained that staff performed numerous in-house design projects, reviewing all public stormwater designs, with the Floodplain Administrator at the helm, as well. In addition, the Stormwater Division handled stormwater quality administration, stormwater code enforcement and management of the Detention Pond Inspection Program.

Mr. Mills went on to report that there were a total of 41 transportation-related projects in various phases of completion. The projects included: rehabilitation, widening or construction of roadways; intersections and/or signal design; bridge design; railroad crossings; streetscapes; and various studies and reports on corridors, signal synchronization, and capacity analysis. The main projects in the works included: the 9<sup>th</sup> Street widening from Elgin Place to Houston Street; 37<sup>th</sup> Street construction from Omaha Street to Albany Street; Kenosha resurfacing from Aspen Avenue to Garnett Road; and Downtown Streetscapes, Phase IV. The 15 water projects underway encompassed ground tanks, distribution lines, various connections, and Water Treatment Plant improvements. Examples of projects in the works under heading of water projects included the Long Term Water Supply Plan, design of a 24-inch waterline from the 5-MG ground storage, tying the two systems together, and design for a 3-MG elevated storage tank. With regard to wastewater, there were about 20 current projects in connection with wastewater treatment plant improvements at both the Broken Arrow Plant and the Regional Metropolitan Utility Authority (RMUA) Haikey Creek Plant, owned jointly with the City of Tulsa. In addition, work was being done on trunk lines, lift stations and force mains. The Aspen Creek Relief Line, the Oneta Road Lift Station Replacement, the 209<sup>th</sup> Street lift station and force main, as well as a Long Term Wastewater System Master Plan, were examples of critical projects being undertaken currently. Finally, referencing stormwater projects, Mr. Mills reported that 10 were underway. Those included drainage improvements for small, neighborhood areas, large regional detention facilities, dam projects and, master drainage plans. Examples of projects in various stages of development included: A Broken Arrow Creek Master Drainage Plan; Stone Ridge and Elm drainage improvements; a 37<sup>th</sup> Street Regional Detention Facility; and drainage improvements on Albany Street, in front of the high school. Parks projects numbered 24, including work on playgrounds, restrooms, athletic facilities, trails, and golf course improvements at Battle Creek. The main parks projects underway were: An Events Park adult softball complex; a community trail network; synthetic turf football fields at Nienhuis Park; the Rose West Dog Park; and an impressive new interactive water feature. There were 18 outstanding public safety and special projects, including ones for the Broken Arrow Police and Fire Departments, along with miscellaneous municipal projects. Mr. Mills related that Fire Station No. 7 was in the design stage and Engineering/Construction was ready to open bidding for the Police Downrange Building. He reported also that the Liberty Park Trail retaining wall repairs had been completed. Stoney Creek Conference Center infrastructure tasks and design of the Center for Arts, Innovation and Creativity were being carried out, as well.

At the conclusion of Mr. Mill's report, Mayor Thurmond asked if there were any questions. City Manager Michael Spurgeon stated that he had a few questions and requests. He requested that Mr. Mills touch on the subject of the contract awarded that night for mill and overlay work on Kenosha Street, from Aspen Avenue to Garnett Road. Mr. Mills informed the Council that Magnum Construction, Inc. was contracted for the project and it was expected that work would begin by the first or second week of May. Mr. Spurgeon asked Mr. Mills to elaborate on the scope of the project. Mr. Mills replied that they were going to mill and overlay the roadway from Aspen Avenue all the way to Garnett Road, where there would be a transition from asphalt to concrete, and they would tie in at that location. In reply to Mr. Spurgeon's inquiry on how long the project would take, Mr. Mills said he believed the contract topped 90 days but it was hoped that it would be done by the time school started in August. Mr. Spurgeon asked that Mr. Mills update the Council the following month on the status of plans for modernization of the Lynn Lane Wastewater Treatment Plant.

Councilman Lester asked how the financial aspect of the Kenosha Street project had developed. Mr. Mills replied that the numbers had turned out very well and they were receiving excellent pricing at a cost of \$850,000, while a little over \$1 million had been budgeted. The 37<sup>th</sup> Street project also came in well below the engineers' estimate and clearly, it was an opportune time for the City to take on such projects.

Mr. Spurgeon asked if Mr. Mills would be able to estimate the total cost of the 120 current projects all together. Mr. Mills answered that it was probably somewhere in the range of \$100 million.

10. **Citizens' Opportunity to Address the Council on General Topics Related to City Business or Services**  
No citizens signed up to speak.

11. **General Council Business**

- A. 17-2052 **Consideration, discussion, and possible approval of the relocation of the Vietnam War Memorial in Central Park to Veterans' Park**

Director of Parks and Recreation Scott Esmond addressed the Council on relocation of Broken Arrow's Vietnam War Memorial. He displayed on the screen an aerial view of the Memorial's current location at the Community Center in Central Park and indicated the spot in Veteran's Park of proposed new location. Photos of the Memorial were shown, including one with the names of servicemen lost in the War and one with insignias of the Marines, Navy, Army and Air Force in black granite laminate. Mr. Esmond reported that a Master Plan had been drafted by R.L. Shears Company, PC and Parks and Recreation were beginning implementation of the Plan. The fountain in place at Veterans' Park was pointed out in a site plan diagram as a point of reference, along with the Women's War Memorial and stage area there. The location of the Childers statue and the American Patriot statue were pointed out to the Council. Mr. Esmond indicated the site of a proposed walkway from Main Street to a plaza, where the granite insignias of branches of the Armed Forces and contributors' plaques would be relocated. Proposed walkways leading from the plaza to the American Patriot sculpture and the fountain were pointed out, as well.

An artistic rendering of R.L. Shear's vision of how the Memorial would look was shown, with Mr. Esmond observing that it would be a great fit as an addition to Veteran's Park. He specified the cost estimate, as shown on the screen, to be roughly \$116,000, though funding was not yet in place. Upon Council's approval of the project, it was slated for inclusion in the FY-2018 Capital Budget proposal.

At the conclusion of the presentation, Councilman Parks commented that he had observed that few visitors took the trouble to cross the street to the site of the Vietnam War Memorial in Central Park, following gatherings honoring veterans that took place in Veteran's Park. He related that he knew most of the young men from Broken Arrow who died in Vietnam and wished to make sure that they were honored and that current and future generations be made aware of their sacrifice. Councilman Lester echoed Councilman Parks' sentiments, relating that three of the fallen men had been classmates of his. He encouraged the Council to lend its approval to the relocation. Vice-Mayor Eudey commented that his father-in-law had been a Vietnam veteran and he thought it important to ensure that Broken Arrow had a proper place to honor those who gave their lives, along with those who came home to a reception that was not always positive. Referring to his experience at the Rooster Days Festival in Central Park, he pointed out that those attending tried to treat it with respect that it deserves, however it makes it difficult when their enjoying the festival activities. Mayor Thurmond voiced his agreement with the Councilmen regarding the need for a more accessible, respectful milieu in which to house the Memorial. In reply to a question posed by Councilwoman Wimpee on the timeframe of the project, Mr. Esmond replied that it could move ahead by late winter or early spring of 2018, after budgeting and further consultation with R.L. Shears.

Mr. Spurgeon informed the Council that he had included the project in his Capital Improvements, budget request proposal, which Council would review the following month. Mr. Esmond's presentation received a round of applause from the Council, the Mayor, staff, and the public in attendance.

- B. 17-2076 **Ratification of Mayor's signature on Community Development Block Grant (CDBG), 2017 Tulsa Urban County, City of Broken Arrow, Resolution No. 1012 and Application for FY 2017 Tulsa Urban County Community Development Block Grant (CDBG) Funds**

Mr. Mills recalled that each year the City was awarded federal funds under the Community Development Block Grant (CDBG) program. The allocation to Broken Arrow for 2017 was \$348,515. The City was obligated to use that money for a designated area covering lower to middle income housing. Engineering/Construction determined that best use of the funds would be to apportion it for two projects. The first project entailed installing a 12-inch waterline down the east side of 1<sup>st</sup> Street, connecting to a 24-inch waterline on Greeley Street and connecting to a 6-inch waterline on Detroit Street. The second project involved a four-block rehabilitation of 4<sup>th</sup> Street, between Detroit and Midway Streets. As the Council was apprised in the fact sheet, about \$80,000 of the federal funds would be used for waterline materials and then, in-house staff, making use of the City's own equipment, would perform the work. The remaining CDBG funds of \$268,715 for the 4<sup>th</sup> Street project, would involve utilizing in-house forces to do milling and overlaying of the pavement. Mr. Mills reported that the Mayor had signed off on it and requested Council's ratification of his signature.

12. Preview Ordinances

A. 17-2061 **Consideration, discussion, and possible preview of an Ordinance repealing Chapter 7 of the Broken Arrow Code, Article VI, Massage Establishments, Section 7-116; repealing all ordinances to the contrary; and declaring an emergency**  
City Attorney Beth Anne Childs reported that the Legislature had passed the Massage Therapy Practice Act, thereby eliminating the City's ability to regulate massage businesses outside of certain circumstances. She explained that with the City of Broken Arrow not having a charter, they couldn't argue home rule and were specifically, exempt from that. The Ordinance under consideration repealed the regulations originally enacted and amended from time to time, with regard to massage practitioners and other businesses. It was recommended that the Ordinance be previewed and set for adoption at the next meeting.

The Mayor also commended Richard Carter for his admirable 23 years of humble service to the City of Broken Arrow, voicing his appreciation.

Councilman Lester stated that, as had been reported on the news that night, the Bever house had been demolished that day – a first step in the plan to established a memorial garden in its place.

Newly elected Vice-Mayor Eudey thanked his fellow Councilmen for their faith in him and pledged to do his best to fulfill their trust.

15. Remarks by City Manager, including Recognition of Recent Accomplishments by Employees and Elected Officials

Mr. Spurgeon congratulated the Mayor on his re-election, on behalf of the administration. He congratulated Council member Wimpee on her election, stating that the administration looked forward to working with her to move the community forward.  
Mr. Spurgeon also shared what Councilwoman Wimpee would be undertaking over the course of the next couple of months. The following day she was to meet with him to go through a schedule that would include initially, 50 to 60 hours visiting every Department within the City government and meeting with their Directors and senior staff. The purpose in doing that was twofold: learning how City government operated and to getting a grasp of the top two or three important issues within each Department. In addition, she would be making half a dozen or more tours of the wastewater treatment plants, water plants, police stations, and fire stations. He shared her eagerness to learn what she needed to know in order to make informed decisions as a member of the City Council.

With regard to the budget, Mr. Spurgeon reported that it was nearly finished and that he would be asking the Council to hold a special session some time towards the end of May, thereby affording members of the Council adequate time to review the proposed budget beforehand. They would need time to go through not only the operating budget, but the Capital budget and the Broken Arrow Municipal Authority (BAMA) budget, as well.

Finally, pointing out that it was the Year of the Parks, as would the next year be also, and that the latest round bond approvals by the voters had taken place, Mr. Spurgeon stated that he could not think of a more appropriate project than relocation of Broken Arrow's Vietnam War Memorial to Veteran's Park. He thanked the Council for their decision in support, adding that as a veteran himself, it meant a lot to him personally as likewise, it would to many others. Barring unforeseen circumstances, it was expected that the project would be completed by next spring.

At approximately 7:07 p.m., Mayor Thurmond entertained a motion to recess in order to enter into the Broken Arrow Municipal Authority and Broken Arrow Economic Development Authority meetings.
