**PERMIT TO RECEIVE, TRANSPORT AND TREAT**

Pursuant to O.S. 27A 2-6-401, the City of Broken Arrow is hereby granted this permit to receive, transport, and/or treat flow from S&S Holdings, Kenosha Villas, Tulsa County, Oklahoma, with reference to Permit No. SL000072170259 dated June 22, 2017.

By acceptance of this permit, the permittee agrees to operate and maintain the facilities in accordance with the "Oklahoma Pollutant Discharge Elimination System Standards" (OAC 252:606) rules and to comply with the state certification laws, Title 59, Section 1101-1116 O.S. and the rules and regulations adopted thereunder regarding the requirements for certified operators.

This permit is issued subject to the following provision and condition:

- 1) That no significant information necessary for a proper evaluation of the project has been omitted or no invalid information has been presented in applying for the permit.
- 2) That receiving, transporting, and/or treatment of wastewater shall not be discontinued without written notice to this office and the entity generating the wastewater, except in case of emergency.

Failure to appeal the conditions of this permit in writing within 30 days from the date of issue will constitute acceptance of the permit and all conditions and provisions.
