2. Project Title and Location: Florence Street Improvements, Olive Avenue to Aspen Avenue.

3. Contract Amendment for: Updating the plans completed and dated December 16, 2014. Services to be provided include, but are not limited to, participation in meetings including utility relocation meetings; update property owner's names and reports, update plans based on City red-lines for a final review and detailed bidding documents including revised quantities for the roadway improvements. All other provisions of the original contract apply.

4. Contract Data:

- a. Amendment No. 2 amount shall not exceed Sixteen Thousand Three Hundred dollars and no cents. (\$16,300.00).
- b. This includes Ten Thousand Three Hundred dollars and no cents (\$10,300.00) as a lump sum payment for Design Services Phase and Six Thousand dollars and no cents (\$6,000.00) as an hourly not to exceed for Construction Services Phase.
- c. The total time allowed for amended completion of Design Services is Sixty (60) calendar days.
