**3.0 Statement of Purpose:** Provide preliminary engineering and the preparation of construction plans for the construction of approximately 2,700 linear feet of an Industrial Minor Collector Street in the vicinity of 9<sup>th</sup> Street between Houston Street and Washington Streets in the City of Broken Arrow, including the extension of a 12-inch water main along the new street. See attached Amendment No. 1 to the agreement.

THIS **AMENDMENT NO. 1**, made and entered into this \_\_\_\_\_ day of August 2017, by and between the CITY OF BROKEN ARROW, OKLAHOMA, a municipal corporation of the State of Oklahoma, hereinafter referred to as "CITY", and Olsson Associates, hereinafter referred to as "ENGINEER";

**WITNESSETH:**

**WHEREAS**, CITY and ENGINEER entered into an Agreement dated February 21, 2017, for services as set forth in said Agreement; and

**WHEREAS**, said Agreement requires ENGINEER to prepare construction documents for bidding purposes for the construction of approximately 2,700 linear feet of Industrial Minor Collector Street in the City of Broken Arrow at a location to be determined, including the extension of a 12-inch water main along the new street (PROJECT) in which OWNER has requested that CONSULTANT provide certain professional services as required and,

**WHEREAS**, CITY and ENGINEER propose to amend said Agreement to expand the project scope, design schedule and compensation to include the preparation of preliminary, final and construction plans and contract documents for the construction of the Industrial Minor Collector Street and the extension of the 12" waterline; and

**WHEREAS**, the 2017 Agreement and First Amendment shall hereinafter collectively be referred to as the "Agreement"; and

**WHEREAS**, funding is now available for said additional services; and

**WHEREAS**, ENGINEER is prepared to provide said additional services identified in this Amendment.

**NOW THEREFORE**, in consideration of the promises contained herein, the parties hereto agree to amend the Agreement as follows:

**1. PROJECT SCOPE.**

This Amendment requires ENGINEER to complete the Preliminary and Final Design phases as stated in the original agreement. Basic scope of the services includes:

- a. The Geotechnical Investigation and Report Phase will be completed with the

schedule revisions as stated in Exhibit 1.

- b. Prepare the Preliminary Design Phase plans as outlined in Section 2.4 of the Scope of Services in the original agreement.
- c. Prepare the Final Design Phase plans as outline in Section 2.4 of the Scope of Service in the original agreement including construction specifications and documents to bid the project.

**2. CHANGE IN CONTRACT AMOUNT.**

As compensation for the additional work, CITY shall pay ENGINEER in accordance with the terms as a change in the contract amount. The Preliminary Phase Payment will be for a lump sum amount of \$75,000.00. The Final Phase Payment will be for a lump sum amount of \$90,000.00. The change in contract amount is:

**3. AMENDED PROJECT SCHEDULE**

A new project schedule for the Geotechnical Investigation and Report Phase, the Preliminary Design Phase and the Final Design Phase as described in the attached Exhibit 1 is hereby incorporated by reference as part of this Agreement.

**4. EFFECTIVE DATE AND AUTHORIZATION TO PROCEED.**

This Amendment No. 1 is effective upon signature by both parties.

Except as amended hereby, all terms of the 2017 Agreement shall remain in full force and effect without modification or change.

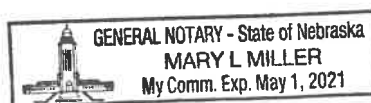
