

UTILITY EASEMENT

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, BD Creekside Apartments Phase I, LLC the owners, of the legal and of the legal and equitable title to the following described real estate, "Grantor," in consideration of the sum of One Dollar (\$1.00), cash in hand paid, receipt of which is hereby acknowledged, does hereby assigns, grants and conveys to the City of Broken Arrow, Tulsa County, Oklahoma, a municipal corporation, its successors and assigns, "Grantee," an easement and right of way over and across the following described real property and premises, situated in Tulsa County, State of Oklahoma to wit:

A TRACT OF LAND THAT IS A PART OF LOT ONE (1), BLOCK ONE (1), CREEKSIDE APARTMENT HOMES, AN ADDITION TO THE CITY OF BROKEN ARROW, TULSA COUNTY, STATE OF OKLAHOMA, ACCORDING TO THE RECORDED PLAT THEREOF, SAID TRACT BEING DESCRIBED AS FOLLOWS:

COMMENCING AT THE MOST WESTERLY SOUTHWEST CORNER OF SAID LOT 1, BLOCK 1; THENCE NORTH 88°37'32" EAST ALONG THE SOUTHERLY LINE OF LOT 1 FOR 292.86 FEET TO THE POINT OF BEGINNING OF SAID TRACT OF LAND; THENCE NORTH 01°22'28" WEST FOR 27.51 FEET; THENCE NORTH 88°37'26" EAST FOR 15.00 FEET; THENCE SOUTH 01°22'28" EAST FOR 79.63 FEET; THENCE SOUTH 88°37'32" WEST FOR 10.54 FEET; THENCE NORTH 01°15'51" WEST FOR 52.12 FEET; THENCE SOUTH 88°37'32" WEST FOR 4.56 FEET TO THE POINT OF BEGINNING OF SAID TRACT OF LAND.

CONTAINING 959.38 SQUARE FEET OR 0.022 ACRES, MORE OR LESS.

with right of ingress and egress to and from the same, for the purpose of constructing, operating, and replacing utility lines and appurtenances.

Grantor agrees not to build or construct any building or buildings upon the permanent easement area. However, Grantor expressly reserves the right to build and construct sidewalks, streets and driveways, water mains, gas lines, electrical lines and other public service facilities across said premises herein described.

There is further granted the right to remove any tree or parts of trees, which in the judgment of the City may interfere with the construction of the applicable utilities.

PROVIDED, that the said Grantor, his/her heirs, executors, administrators and assigns, shall fully use and enjoy the said premises except as may be necessary for the purposes herein granted to the City, its successors or assigns.

TO HAVE AND TO HOLD such easement and right of way unto the City of Broken Arrow, Oklahoma, its successors and assigns forever.

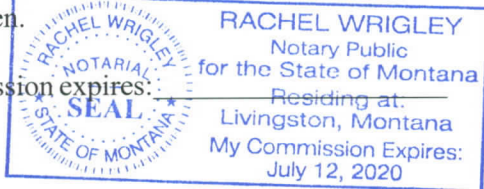
