## **Project Goals:**

To decrease the number of unsafe speed-related KAB crashes in Broken Arrow from 38 in 2015 to 34 in 2018. (OHSO Crash Facts data)

To decrease the number of pedestrians involved in crashes in Tulsa County from 196 in 2015 to 165 in 2018. (OHSO Crash Facts data)

### Problem Identification:

Broken Arrow is the fourth largest city in Oklahoma with a population of 107,000 and is continuing to grow. Geographically, the city limits encompass 55 square miles and has a fence line of 107 miles. The Broken Arrow Police Department provides traffic services for over 1,681 lane miles of roadway, much of which is multi-lane arterial streets and one state highway. According to 2015 data from the Oklahoma Highway Safety Office, Broken Arrow is ranked 14 out of 76 for unsafe speed KAB crashes and had 38 unsafe speed KAB crashes with 3 of them being fatal. There was 1 pedestrian fatality and 0 bicyclist fatalities in Broken Arrow; however, for the Tulsa County area, there were 19 pedestrian fatalities and 0 bicyclist fatalities. According to 2015 data from the Oklahoma Highway Safety Office, the top 3 contributing factors that caused the pedestrian fatalities included Crossing Not at Intersection, Walking/Riding with Traffic and In Roadway (Standing, on Knees, Lying, Etc.).

### **Project Description:**

The Broken Arrow Police Department will conduct high visibility enforcement utilizing overtime hours in support of State and National goals to reduce the incidence of KAB crashes in their community. This will be accomplished through enhanced enforcement efforts using officers working in an overtime capacity. The Project Director will utilize the following distribution of funding for overtime enforcement activity: Speed (84%), Bicycle/Pedestrian (9%) and Car Seat Checks (7%).

As a primary objective, the Project Director will utilize all data and reference sources available to identify those times and locations having a significant crash rate involving unsafe speed, including but not limited to crash reports, arrest records, and public complaints. Officers will be assigned to work high visibility enforcement and saturation patrols in the identified areas. In the high visibility enforcement model, officers focus on drivers who commit common aggressive driving actions such as speed, following too closely, and running red lights. Enforcement will be publicized using public information and education events conducted to inform the

public of traffic safety issues and related events occurring in the city.

As a secondary objective, the Broken Arrow Police Department will also conduct overtime bicycle/pedestrian enforcement by utilizing patrol and/or bicycle officers to work targeted enforcement for bicyclists traffic violations. This would also be incorporated in and around the bicycle paths and high pedestrian traffic areas within the city limits. Enforcement would also be utilized during special events in the city such as Rooster Days, Rockets over Rhema, Gatesway Balloon Festival and like events. The Broken Arrow Police Department would also focus efforts in and around neighborhoods with bus routes targeting vehicles parking in crosswalks and pedestrians/bicyclists not using the crosswalks and any other violations that would contribute to bicycle or pedestrian safety. There are plans to coordinate with the schools to allow officers to ride a bus and radio violations observed during the transport of children. Social media posts could also be utilized to promote Spot the Tot programs in conjunction with Safe Kids. As the third objective, the Broken Arrow Police Department's car seat technicians will work overtime during car seat checkup events conducted in Broken Arrow in cooperation with Tulsa SafeKids. Broken Arrow has 3 certified technicians.

Public information and education events will be conducted to inform the public of traffic safety issues as well as bicycle/pedestrian safety.

External and in-vehicle technologies such as in-car video equipment, radar and Lidar speed measuring devices may be utilized. These technologies assist officers in providing accurate and reliable evidence of violations and enhance the ability to prosecute and convict offenders. Speed display trailers may also be used to alert drivers that they are speeding and encourage drivers to slow down.

The Broken Arrow Police Department will employ the following evidence-based strategies in conducting grant related activities:

- 1. Speed Limits
- 2. Aggressive Driving and Other Laws
- 3. High-Visibility Enforcement
- 4. Safe Routes to School
- 5. Targeted Enforcement

## General Provisions - Part II

## **REGULATIONS AND DIRECTIVES**

L. 100-259), which requires Federal-aid recipients and all subrecipients to prevent discrimination and ensure nondiscrimination in all of their programs and activities; (f) the Drug Abuse Office and Treatment Act of 1972 (Pub. L. 92-255), as amended, relating to nondiscrimination on the basis of drug abuse; (g) the comprehensive Alcohol Abuse and Alcoholism Prevention, Treatment and Rehabilitation Act of 1970 (Pub. L. 91-616), as amended, relating to nondiscrimination on the basis of alcohol abuse or alcoholism; (h) Sections 523 and 527 of the Public Health Service Act of 1912, as amended (42 U.S.C. 290dd-3 and 290ee-3), relating to confidentiality of alcohol and drug abuse patient records; (i) Title VIII of the Civil Rights Act of 1968, as amended (42 U.S.C. 3601, et seq.), relating to nondiscrimination in the sale, rental or financing of housing; (j) any other nondiscrimination provisions in the specific statute(s) under which application for Federal assistance is being made; and (k) the requirements of any other nondiscrimination statute(s) which may apply to the application.
- 3. Hatch Act (Political Activity), 5 U.S.C. Sections 1501-1508 and 5 CRF Part 151.
- 4. Buy America Act, 23 U.S.C. 101.
- 5. Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion Lower Tier Covered Transactions:

Any person who fails to file the required certification shall be subject to civil penalty of not less than \$10,000 and not more than \$100,000 for each such failure.

- Restriction on State Lobbying; None of the funds under this program will be used for any activity specifically designed to

urge or influence a State or local legislator to favor or oppose the adoption of any specific legislative proposal pending
