Project Details

The Property is being re-platted for expansion of retail development. The subject easements or rights of way are no longer required for public purposes, and it is necessary and expedient and in the public interest, for the health, welfare and best interests of the citizens of the City of Broken Arrow, to manage and facilitate appropriate pedestrian and vehicular traffic flow, or to facilitate the efficient provision and disposition of utility services, and to eliminate unnecessary maintenance, that the subject easements or rights of way described in the attachments should be closed, discontinued and abandoned.
