Jane Wyrick, Planner II, presented the background for Item 4A saying, Item 4 is for the acceptance of an amendment to the Deed of Dedication and Restrictive Covenants for the Tee Town Golf Ranch plat, located east of 37th Street, one-third mile south of Kenosha Street in Wagoner County.

Ms. Wyrick said Specific Use Permit (SP-285) was approved by the City Council on October 17, 2017 for a place of assembly for The Ridge at Broken Arrow, subject to conditions. This approval was per the recommendations of the Planning Commission and Staff. One of the conditions of approval for SP-285 required the applicant to draft a separate written instrument for the Planning Commission's signature to amend the use restrictions on the plat. The development restrictions within the covenants limit the use restrictions of the use of the golf driving range.

Jane Wyrick said the item being presented is the proposed separate instrument amendment to the deed of dedication and restrictive covenants. The language within the amended plat restrictions allow for any and all uses permitted by the underlying zoning of the property. Acceptance of this request and recording the amendment with Wagoner County will satisfy said condition of approval included with SP-285. She said Staff recommends approval and the applicant is available for questions.

Lee Whelpley explained the Consent Agenda and asked if anyone wished to remove any items for discussion. No one responded.
