




CERTIFICATE OF DEDICATION AND RESTRICTIVE COVENANTS

KNOW ALL MEN BY THESE PRESENTS:

That AIR COOLED EXCHANGERS, INC., An Oklahoma Corporation, is the owner of the following described real estate situated in Tulsa County, Oklahoma, to-wit:

All of Blocks 1 and 2, LYNN LANE INDUSTRIAL PARK, an Addition to the City of Broken Arrow, Tulsa County, Oklahoma, according to the recorded plat thereof.

AND that the above owner has caused the same to be platted into lots, blocks, and streets as shown by the accompanying plat, and does further dedicate for public use forever the easements and rights-of-way as shown and designated on the accompanying plat for the several purposes of constructing, maintaining, operating, repairing, removing and replacing any and all public utilities, including storm sewers, sanitary sewers, telephone lines, electric power lines and transformers, gas lines and water lines, together with all fittings and equipment for each of such facilities, including the poles, wires, conduits, pipes, valves, meters, and any other appurtenances thereto, with the right of ingress and egress to and upon said easements and rights-of-way for the uses and purposes aforesaid, together with similar rights in each and all of the streets shown on said plat; PROVIDED HOWEVER, that the undersigned owners hereby reserve the right to construct, maintain, operate, lay and relay, water and sewer lines together with the public streets shown in said plat, and over, across and along all strips of land included within the easements shown thereon, both for the purpose of furnishing water and/or sewer service to the area included in said plat, and to any other areas. The owner hereby relinquishes right of ingress and egress to the above described property within the bounds designated as "Limits of No Access" (LNA) except as may hereafter be released, altered, or amended by the Broken Arrow Planning Commission or its successors, or as otherwise provided by the Statutes and laws of the State of Oklahoma pertaining thereto.
