RESOLUTION NO. 1101

A RESOLUTION OF THE BROKEN ARROW CITY COUNCIL AUTHORIZING THE CITY LEGAL DEPARTMENT TO FILE AN ACTION IN DISTRICT COURT TO OBTAIN A DECREE ORDERING THE ABATEMENT OF A PUBLIC NUISANCE REGARDING THE PROPERTY LOCATED AT 1124 W. FLORENCE CT., BROKEN ARROW, OKLAHOMA, 74011

WHEREAS, the property located at 1124 W. Florence Ct., Broken Arrow, Oklahoma, 74011, was inspected by representatives of the City of Broken Arrow who determined that the main structure in its present condition constitutes not only a menace to the health and safety of the public, but is also a public nuisance; and

WHEREAS, on December 8, 2017, a Notice to Abate a Nuisance public hearing letter was mailed to the owner of the property by United States Postal Service at 7060 S. Yale, Ste 200, Tulsa, Oklahoma 74136, at the address shown at the current year's tax rolls in the Tulsa County Treasurer's office, namely: BOKF N.A., 7060 S. Yale, Ste 200, Tulsa, Oklahoma 74136; and

WHEREAS, that the public hearing held on February 1, 2018, Russell Gale, the Hearing Officer for the City of Broken Arrow, Oklahoma, found the structure at 1124 W. Florence Ct., Broken Arrow, Oklahoma, 74011, to be in violation of City Ordinance § 15-1.C(15) and 15-4, and Oklahoma State Statute, Title 11, O.S. §§ 22-111, 112; and

WHEREAS, following the public hearing on February 1, 2018, an Order of Abatement was issued finding that the structure in its present condition was a dilapidated structure in violation of City Ordinance 15-1.C(15) and 15-4, and Oklahoma State Statute, Title 11, O.S. §§ 22-111, 112; and

WHEREAS, the above-described public nuisance remains unabated.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BROKEN ARROW, OKLAHOMA, that the main structure on the property legally described as Lot 19, Block 2, Florence Court Addition to the City of Broken Arrow, Tulsa County, State of Oklahoma, according to the recorded Plat No. 4336, and locally known as 1124 W. Florence Ct., Broken Arrow, Oklahoma, 74011, has previously been declared a public nuisance; and

BE IT FURTHER RESOLVED that the Acting City Attorney is hereby authorized to file an action in District Court pursuant to 50 O.S. § 17, to obtain a Decree ordering the abatement of the public nuisance and should the owner fail to abate the nuisance as ordered, that the matter may be referred to the Development Services Department to take all necessary action to demolish and remove said main structure.
