Changes may be made to this agreement with addition or removal of structures that are being treated.

SPECIAL GUARANTEE: We agree to apply the products used in accordance with terms and conditions of this Service Agreement. All labor and materials will be furnished to provide the most efficient pest control and maximum safety required by federal and state regulations.

TERMS AND CONDITIONS: Arrow will service the premises at least once each month, quarter or year (as specified) in order to control the pests checked above. If additional service is requested by the customer between the regular service visits, service will be performed at no additional cost to the customer, if an actual problem does exist. A \$25.00 service call will be charged if no problem is detected.

The customer agrees to make the premises available for inspection and treatment as often as necessary to control the pests during the duration of this agreement. Extra service for Ants on monthly services only. Quarterly services may be charged a trip charge or switched to monthly service if ant problem persists.

This agreement will be for an initial period of one year.
