

Ordinance No. \_\_\_\_\_

**An ordinance closing an overland drainage easement on property located north and west of the northwest corner of Dearborn Street and 37<sup>th</sup> Street, Wagoner County, State of Oklahoma, (Section 19, T19N, R15E); repealing all ordinances to the contrary; and declaring an emergency**

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROKEN ARROW, OKLAHOMA:**

**SECTION I.** The detention easement affecting the real estate described as follows:

Tract 1

A tract of land **Beginning** at a point on the south line and 955.46 feet west of the Southeast corner of said Section Nineteen (19); Thence N 89°49'42" W and along the southerly line a distance 302.00 feet; Thence N 0°10'18" E and perpendicular to the Southerly line a distance of 50.00 feet; Thence N 44°49'42" W a distance of 35.36 feet; Thence N 0°10'18" E and perpendicular to the Southerly line, a distance of 270.00 feet; Thence S 89°49'42" E and parallel with the Southerly line a distance of 388.73 feet; Thence S 0°15'12" W a distance of 142.78 feet; Thence S 89°39'14" W a distance of 64.06 feet to a point; Thence S 0°32'55" E a distance of 201.67 feet to the **Point of Beginning**. Tract contains 2.75 acres less the South 50.00 feet thereof consisting of 0.35 acres for statutory and public right-of-way.

Tract 2

A tract of land **Beginning** at a point on the east line and 991.68 feet north of the Southeast corner of said Section Nineteen (19); Thence N 89°45'44" W and perpendicular to the easterly line a of distance of 98.16 feet to a point; Thence S 41°52'50" W a distance of 238.96 feet to a point; Thence S 17°21'45" W a distance of 153.34 feet to a point; Thence S 31°28'40" W a distance of 175.44 feet to a point on the north line of Glen Eagles Commercial; Thence S 89°49'42" E and parallel with the south line of the Southeast Quarter (SE/4) a distance of 393.09 feet to the northeast corner of Glen Eagles Commercial; Thence N 0°14'16" E along the Easterly line of the Southeast Quarter (SE/4) a distance of 474.68 feet to the **Point of Beginning**. Tract contains 2.86 acres less the East 50.00 feet thereof consisting of 0.54 acres for statutory and public right of way.

A tract of land **Beginning** at a point on the east line and 1755.59 feet north of the Southeast corner of said Section Nineteen (19); Thence N 89°45'44" W and perpendicular to the easterly line a distance of 67.50 feet to a point; Thence S 48°13'12" W a distance of 169.20 feet to a

point; Thence S 62°41'54" W a distance of 117.51 feet to a point; Thence S 05°00'26" W a distance of 103.29 feet to a point; Thence S 27°25'03" E a distance of 74.30 feet to a point; Thence S 61°49'58" W a distance of 83.58 feet to a point; Thence S 15°33'31" W a distance of 168.56 feet to the north Right-of-Way of East Gillette Street and a point in a curve; Thence southeast on a curve to the left having a radius of 725.00 feet and arc length of 205.50 feet, a delta 16°14'25", with a chord bearing of S 81°38'31" E and a chord length of 204.81 feet to a point of tangent; Thence S 89°45'44" E a distance of 111.80 feet to a point; Thence N 45°14'16" E a distance of 35.36 feet; Thence S 89°45'44" E a distance of 50.00 feet to the east line of the Southeast Quarter (SE/4); Thence N 00°14'16" E and along the east line of the Southeast Quarter (SE/4) a distance of 542.59 feet to the **Point of Beginning**. Said tract contains 3.62 acres, less the South and East 50.00 foot thereof consisting of 0.62 acres of statutory and public right-of way.

#### Tract 4

A tract of land **Beginning** at the northwest corner of Lot 2 Block 2 of Glen Eagles III subdivision; Thence S 61°33'17" E for a distance of 165.78 feet to the northeast corner of said Lot 2; Thence N 75°09'54" E away from said Glen Eagles III east line a distance of 56.47 feet to a point; Thence N 04°02'07" W a distance of 99.09 feet to a point; Thence N 66°36'12" W a distance of 115.93 feet to a point; Thence N 30°29'50" W a distance of 48.36 feet to a point; Thence S 70°05'16" W a distance of 47.38 feet to a point in a curve on the east Right-of-Way of North 35th Street; Thence southwest, on a curve to the right having a radius of 50.00 feet and an arc length of 52.84 feet, a delta 60°33'14", with a chord bearing of S 12°46'57" W and a chord length of 50.42 feet to a point of reverse curve; thence southeast, on a curve to the left having a radius of 25.00 feet and an arc length of 18.79 feet, a delta 43°04'10", with a chord bearing of S 21°31'54" E and a chord length of 18.35 feet to a point of tangent; Thence S 0°00'00" E a distance of 39.67 feet to the **Point of Beginning**. Said tract contains 0.56 acres more or less.

#### Tract 5

A tract of land **Beginning** at the northeast corner of Lot 9 Block 3 of Glen Eagles III subdivision; Thence S 0°03'26" W and along the east line of said Block 3 a distance of 322.21 feet; Thence S 89°51'55" E a distance of 250.00 feet; Thence S 24°37'26" E a distance of 109.68 feet; Thence N 62°22'34" E and away from said Right-of-Way a distance of 59.23 feet to a point; Thence N 13°04'52" W a distance of 37.69 feet to a point; Thence N 56°39'22" E a distance of 77.30 feet to a point; Thence N 07°04'40" W a distance of 51.81 feet to a point; Thence N 60°31'45" W a distance of 118.82 feet to a point; Thence S 32°05'43" W a distance of 73.54 feet to a point; Thence N 60°30'27" W a distance of 150.28 feet to a point; Thence N 23°49'13" E a distance of 87.21 feet to a point; Thence N 55°34'05" E a distance of 70.84 feet to a point; Thence N 03°21'54" W a distance of 84.68 feet to the south Right-of-Way of East Irvington Street and a point of curve; thence southwest on a curve to the right having a radius of 390.00 feet and arc length of 91.03 feet, a delta 13°22'24", with a chord bearing of S 83°26'53" W and a chord length of 90.82 feet to a point; Thence continuing along said right-of-way N 89°51'55" W a distance of 122.64 feet to the **Point of Beginning**. Said tract contains 1.90 acres more or less.

Tract 6

**Beginning** at a point 889.64 feet west of the northeast corner of the Southeast Quarter of said Section Nineteen (19) and Northeast corner of Lot 5 Block 1 of Glen Eagles II subdivision; Thence S 00°03'26" W along the east line of said Glen Eagles II distance of 512.13 feet to the southeast corner of Lot 1 Block 1 and a point on the north Right-of-Way of East Irvington Street; Thence N 89°51'55" E a distance of 26.64 feet to a point of curve; Thence northeast on a curve to the left having a radius of 330.00 feet and arc length of 58.76 feet, a delta 10°12'09", with a chord bearing of N 85°02'02" E and chord length of 58.68 feet to a point of tangent; Thence N 00°02'58" W a distance of 23.45 feet to a point; Thence N 78°30'04" E a distance of 51.79 feet to a point; Thence S 02°04'20" W a distance of 22.57 feet to a point; Thence N 76°45'40" E a distance of 97.26 feet to a point of curve; Thence northeast on a curve to the right having a radius of 390.00 feet and arc length of 215.23 feet, a delta 31°37'13", with a chord bearing of N 87°25'42" E and chord length of 212.51 feet to a point of tangent; Thence N 24°29'36" E and away from said Right-of-Way a distance of 193.46 feet to a point; Thence N 00°40'31" E a distance of 183.09 feet to a point; Thence N 36°13'32" E a distance of 151.95 feet to a point on the north line of the Southeast Quarter (SE/4); Thence N 89°51'55"W along said north line a distance of 613.86 feet to the **Point of Beginning**. Said tract contains 5.74 acres more or less.
