1. Call To Order

Hearing Officer Russell Gale called the Nuisance Abatement Public Hearing to Order at 12:00 PM.

2. Approval of Previous Minutes

18-870 **Approval of Nuisance Abatement Public Hearing Minutes of July 5, 2018**

3. Nuisance Abatements for Consideration

18-870 **Consideration, discussion and possible declaration that 1617 South Pine Avenue, Broken Arrow, OK 74012; LT 5 Block 16 Stacey Lynn Fifth, Tulsa County; as a dilapidated structure and a public nuisance and authorization to demolish the property. Violations: Title 11 O.S. § 22-111 and § 22-112; City Nuisance Code 15-1 C.15 and 15-4 and 15-1 D.10 a & b.**

Code Enforcement Officer Valerie Holbrook advised that after due diligent process there had been no effort from the property owner to fix the property in question. Property owner was not in attendance. Mortgage and/or Title Company was not in attendance.

Hearing Officer Russell Gale approved demolition of the dilapidated structure.

4. Continued Business

18-866 **Consideration, discussion and possible declaration that 710 North 1st Street, Broken Arrow, OK 74012; Lot 7 Block 9 Brown's, Tulsa County; as a dilapidated structure and a public nuisance and authorization to demolish the property.**

Chief Building Inspector Joe Williford advised the Managers from Stormwater and Engineering prepared plans for the drainage issues in the area which was estimated to be completed in approximately 90-Days. A copy of the plans were provided to the homeowners. In order to move this project along, Chief Building Inspector Joe Williford suggested the homeowners go

ahead and start the process of submitting either a building permit or demolition permit within 60-Days, since the drainage issues were being resolved by the city.

Property owner Bud Russell appeared. He requested a 90-Day extension before obtaining any permits.

Hearing Officer Russell Gale reset this matter for October 4, 2018, to determine if the street department had completed the improvements that were proposed by the Engineering Department. The building permit and demolition permit to be submitted by the homeowner will be addressed at the hearing on October 4, 2018.

Consideration, discussion and possible declaration that 19223 East 101st Street South, Lot 1 Block 1, County Line Food Mart, Tulsa County; as a dilapidated structure and a public nuisance and authorization to demolish the property; Case No. 18-10029649. Violations: Title 11 O.S. § 22-111 and § 22-112; City Nuisance Code 15-1 C.15 and 15-4 and 15-1 D.10 a & b.

Chief Building Inspector Joe Williford requested this case be tabled for 120-Days. The property owner is waiting on a response from AEP-PSO to purchase some property in order to relocate the driveways. They have met with Development Services to work on plans to demolish the structure and rebuild a new structure.

Attorney Lou Reynolds appeared on behalf of the property owners. He agreed with the recommendations of Chief Building Inspector Joe Williford to extend this case for 120-Days.

Hearing Officer Russell Gale approved the extension of 120-Days and reset this case to be heard at the hearing on December 6, 2018.
