### **DEED DEDICATION AND RESTRICTIVE COVENANTS**

KNOW ALL MEN BY THESE PRESENTS:

THAT Quapaw Investments, L. L. C., an Oklahoma limited liability company and Dunham Six LLC, an Oklahoma limited liability company, hereinafter collectively referred to as the "Owners", are the Owners of the following described real estate situated in the City of Broken Arrow, Tulsa County, State Oklahoma, to-wit:

Part of West-half Southwest Quarter Southwest Quarter (W/2 SW1/4 SW1/4) of Section Twenty-seven (27), Township Eighteen (18) North, Range Foundation (14) East, of the Indian Base and Meridian, Tulsa County, Oklahoma, according to the United State Government Survey and being more particularly described as follows:

COMMENCING at the Southwest Corner of Section Twenty-seven (27); thence by bearing and distance (basis of bearing, Grid North) North 01°26'30" along the west line of said Section Twenty-seven (27) a distance of 80.63 feet; thence leaving said west line, North 88°33'30" East a distance of 70.00 f a one-half inch (1/2") rebar with PLS #1700 cap on the east right-of-way line of S. Aspen Avenue as established by Deed of Dedication, Document No. 2011026502, filed March 28, 2011, for the POINT OF BEGINNING; thence North 01°26'30" West along said east right-of-way line a distance of 274.16 f a one-half inch (1/2") rebar with PLS #1700 cap; thence leaving said east right-of-way line, North 88°43'54" East a distance of 200.20 to a one-half inch (1/2") rebar with PLS #1700 cap; thence South 01°26'30" East a distance of 285.00 feet a one-half inch (1/2") rebar with PLS #1700 cap on the north right-of-way line of W. Florence Street, also established by said Deed of Dedication, Document No. 2011026502; thence South 88°43'54" West along sa north right-of-way line a distance of 189.36 feet to a one-half inch (1/2") rebar with PLS #1700 cap on the northeasterly right-of-way line of W. Florence Street, as established by Agreed Journal Entry of Judgement, Case Number CV-2010-00810, filed for record as Document No. 2011012712, February 10 2011; thence North 46°21'26" West along said northeasterly right-of-way line a distance of 15.35 feet to the Point of Beginning.

THE Owners have caused the above described lands to be surveyed, staked, platted and subdivided into one lot and one block, as shown by the accompanying plat, and has designated this subdivision to be CASEY'S GENERAL STORE 2, Lot 1, Block 1, an addition to the City of Broken Arrow, Tulsa County, Oklahoma.

NOW, therefore, the Owners being the owners of all the property herein above described, for the purpose of providing for the orderly development of CASEY'S GENERAL STORE 2, Lot 1, Block 1, and for the purpose of insuring adequate covenants and restrictions for the mutual benefit of the Owners, successors, grantees and assigns, and the City of Broken Arrow, Oklahoma, the beneficiaries of the covenants set forth in Section I below, with respect such covenants only, do hereby impose the following restrictions and covenants, which shall be covenants running with the land and which shall be enforceable by the Owners or the Owners of said CASEY'S GENERAL STORE 2, Lot 1, Block 1, and by the beneficiaries of the covenants set forth in Section below, with respect to such covenants only and which shall be enforceable as hereinafter set forth.

### SECTION I. PUBLIC STREETS AND UTILITY EASEMENTS

The Owners hereby dedicates to the public the street rights-of-way depicted on the accompanying plat. The Owners further dedicates to the public th utility easements designated as 'U/E' or 'utility easement' for the several purposes of constructing, maintaining, operating, repairing and replacing, and removing any and all public utilities, including storm sewers, sanitary sewers, telephone and communication lines, electric power lines and transformer gas lines, water lines and cable television lines, together with all fittings, including the poles, wires, conduits, pipes, valves, meters, manholes and equipment for each of such facilities and any other appurtenances thereto, with the rights of ingress and egress to and upon the utility easements for uses and purposes stated, provided the Owners reserve the right to construct, maintain, operate, lay and repair or replace water lines and sewer lines together with the right of ingress and egress for such construction, maintenance, operation, laying, repairing and re-laying over, across and along all o utility easements depicted on the plat, for the purpose of furnishing water and/or sewer services to areas depicted on the plat. The Owners herein important of the plat is the owners herein important of the plat. a restrictive covenant, which covenant shall be binding on each lot owner and shall be enforceable by the City of Broken Arrow, Oklahoma, and by the supplier of any affected utility service, that within the utility easements depicted on the accompanying plat no building, structure or other above or be ground obstruction that interferes with stated uses and purposes of the utility easements shall be placed, erected, installed or maintained, provided nothing herein shall be deemed to prohibit drives, parking areas, curbing, landscaping and customary screening fences which do not constitute an obstruction.

1.1 WATER, SANITARY SEWER, AND STORM SEWER SERVICE

1.1.1 The owner of the lot shall be responsible for the protection of the public water mains, sanitary sewer mains, and storm sewers located on his/he 1.1.2 Within the utility easement, waterline, sanitary sewer, storm sewer and drainage easement areas depicted on the accompanying plat, the alteration of the second se of grade from the contours existing upon the completion of the installation of a public water main, sanitary sewer main, or storm sewer or any constru activity that would interfere with public water mains, sanitary sewer mains, and storm sewers shall be prohibited.

1.1.3 The City of Broken Arrow, Oklahoma, or its successors, shall be responsible for ordinary maintenance of sanitary sewer mains, and storm sewers, the owner of the lot shall pay for damage or relocation of such facilities caused or necessitated by acts of the owner of the lot, his agents or contracto 1.1.4 The City of Broken Arrow, Oklahoma, or its successors, shall at all times have right of access to all easements depicted on the accompanying plat, otherwise provided for in this Deed of Dedication, for the purpose of installing, maintaining, removing or replacing any portion of underground sanitar sewer, or storm sewer facilities.

1.1.5 The foregoing covenants set forth in the above paragraphs shall be enforceable by the City of Broken Arrow, Oklahoma, or its successors, and the owner of the lot agrees to be bound hereby

1.1.6 The City of Broken Arrow, Oklahoma, or its successors, shall be responsible for ordinary maintenance of public water mains but the owner of the shall pay for damage or relocation of such facilities caused or necessitated by acts of the owner of the lot, his agents or contractors. 1.1.7 Owners acknowledge and agree that driveways and sidewalks will be constructed upon and subject to the City of Broken Arrow and the City of Br Arrow will not be responsible for damage to or interference with such driveways or sidewalks for use, maintenance or replacement of lines within such easements.

#### 1.2 PAVING AND LANDSCAPING WITHIN EASEMENTS

The owner of the lot depicted on the accompanying plat shall be responsible for the repair or damage to landscaping and paving occasioned by installa or necessary maintenance of underground water, sanitary sewer, storm sewer, natural gas, communication, cable television or electric facilities withir easement areas depicted upon the accompanying plat, provided the City of Broken Arrow, Oklahoma, or its successors, or the supplier of the utility se shall use reasonable care in the performance of such activities.

**1.3 RESERVATION OF RIGHTS AND COVENANTS AS TO OBSTRUCTIONS** 

The Owner hereby reserves the right to construct, maintain, operate, lay and re-lay water lines and sewer lines, together with the right of ingress and egress for such obstruction, maintenance, operation, laying and re-laying over, across and along all of the utility easements depicted on the plat, for the purpose of furnishing water and/or sewer services to the area included in the plat and to areas outside of the plat. The owner herein imposes a restrict covenant, which covenant shall be binding on the owner of any lot and shall be enforceable by the City of Broken Arrow, Oklahoma, or its successors, by the supplier of any affected utility service, that within the utility easements depicted on the accompanying plat, no building, structure or other above below ground obstruction shall be placed, erected, installed or maintained, provided nothing herein shall be deemed to prohibit drives, parking areas, curbing, landscaping and customary screening fences that do not constitute an obstruction.

1.4 CERTIFICATE OF OCCUPANCY RESTRICTIONS

No Certificate of Occupancy for a building within the subdivision shall be issued by the City of Broken Arrow until construction of the required infrastru (streets, water, sanitary sewer and storm sewer systems) serving the entire subdivision has been completed and accepted by the City of Broken Arrow Notwithstanding the foregoing, the City of Broken Arrow may authorize the phasing of the construction of infrastructure within the subdivision, and if phasing is authorized, a Certificate of Occupancy for a building within an authorized phase may be issued upon the completion and acceptance of the infrastructure serving the particular phase. The City of Broken Arrow's acceptance shall be evidenced by a document executed by the Mayor of the Cit Broken Arrow (the "formal acceptance") and filed in the records of the Tulsa County Clerk. Building construction occurring prior to recording of the Cit acceptance of infrastructure shall be at the risk of the owner of the lot, notwithstanding the issuance of a building permit.
