AN ORDINANCE AMENDING ORDINANCE NO. 817 AND INCORPORATING WITHIN THE CITY LIMITS OF THE CITY OF BROKEN ARROW, OKLAHOMA, A TRACT OF LAND LYING CONTIGUOUS THERETO AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BROKEN ARROW, OKLAHOMA:

SECTION 1: That the following described tracts of land lying adjoining the present corporate limits of the City of Broken Arrow, Oklahoma, to-wit:

The West 208.75 feet of the East 587.50 feet of the North 417.5 feet of the NE/4 of the NE/4 of Section 11, Township 18 North, Range 15 East, containing (2 acres) more or less;

AND

A tract described as beginning at the Southeast corner of the SE/4 of Section 3, Township 18 North, Range 15 East, thence North 622.6 feet, thence West 425 feet, thence South 55 feet, thence Southwesterly 190 feet, thence South 305 feet, thence East 562 feet to the point of beginning, containing 6 acres, more or less;

be and the same are hereby annexed to the City of Broken Arrow, Oklahoma, and the corporate limits of said City be and the same are hereby extended to include the above described tracts of land.

SECTION 2: That from and after the time this Ordinance becomes effective, the real estate described in Section 1 hereof shall be a part of the City of Broken Arrow, Oklahoma, and all persons residing therein, and all property, both real and personal, attached thereto and therein, shall be and is hereby declared to be subject in all respects and particulars to the jurisdiction, control, laws and ordinances of the City of Broken Arrow, Oklahoma.

SECTION 3: That an emergency exists for the preservation of the public health, peace and safety and by reason whereof, this Ordinance shall take effect from and after its passage, approval, and publication.
