Oklahoma Statutory Form

EXHIBIT "A"

LEGAL DESCRIPTION:

A strip, piece or parcel of land lying in part of the E½ SE¼ SE¼ SW¼ of Section 28, Township 18 North, Range 14 East, IM, Tulsa County, Oklahoma. Said parcel of land being described by metes and bounds as follows:

Beginning at the Southeast corner of the SW¼ of said Section 28, thence S 88°34'42" W along the South line of said E½ SE¼ SE¼ SW¼ a distance of 330.13 feet to the Southwest corner of said E½ SE¼ SE¼ SW¼, thence N 01°25'18" W along the West line of said E½ SE¼ SE¼ SW¼ a distance of 40.00 feet, thence N 88°34'42" E on a line parallel with and 40.00 feet North of said South line a distance of 189.03 feet, thence N 01°25'18" W a distance of 10.00 feet, thence N 88°34'42" E on a line parallel with and 50.00 feet North of said South line a distance of 141.10 feet to a point on the East line of said E½ SE¼ SE¼ SW¼, thence S 01°25'21" E along said East line a distance of 50.00 feet to point of beginning.

Containing 0.15 acres (6446 Sq. Ft.) more or less, of new right of way, the remaining area included in the above description being statutory right of way occupied by the present road.



