WHEREAS, the Board of Regents for Northeastern State University owns, leases, and rents property, namely the Northeastern State University Broken Arrow Plat, within the city limits of the City of Broken Arrow and,

WHEREAS, the Board of Regents for the State of Oklahoma acting for and on behalf of Northeastern State University Police Department/Emergency Management and the City of Broken Arrow have duly established an emergency management point of distribution during an emergency for the purpose of providing parking lot space and rest room facilities during the activation of the Point of Distribution (POD) for our community and

WHEREAS, Title 63 O.S. 2006, Section 695.1 Authorizes agreements between Board of Regents/Governing Board and Municipalities for the purpose of sharing of resources that may be available in a jurisdiction during an emergency or disaster.

NOW, THEREFORE, the Board of Regents for the State of Oklahoma acting for and on behalf of Northeastern State University, hereinafter referred to as "Board," and the City of Broken Arrow Municipal Corporation, hereinafter referred to as "City," agree as follows:

- 1. The Board will allow the City of Broken Arrow is open up a self-sustaining Point of Distribution (POD) on the farthest portion of the northeast corner parking lot for the purpose of distribution of bottled water, meals ready to eat (MRE), to include blue tarps for the covering the roof of damaged homes, during an emergency/incident in the City of Broken Arrow jurisdictional areas.
- 2. The Board will allow the City of Broken Arrow, State of Oklahoma, or Federal Emergency Management Agency use of rest room facilities during daylight hours of operation of the POD.
