KNOW ALL MEN BY THESE PRESENTS:

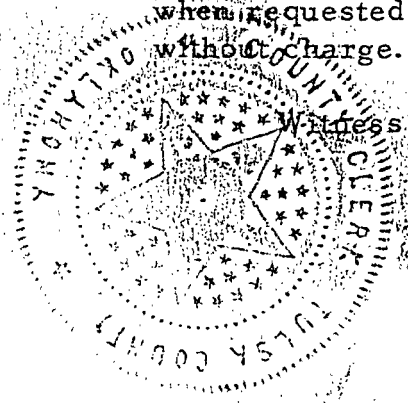
That A. L. GRAHAM and EMMA LEW GRAHAM, husband and wife, of Wagoner County, State of Oklahoma, parties of the first part, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, in hand paid, the receipt whereof is hereby acknowledged, do hereby, for themselves and their heirs, executors, administrators and assigns, grant and convey unto THE CITY OF BROKEN ARROW, OKLAHOMA, A municipal corporation, party of the second part, its successors and assigns, an easement and right-of-way over, under and across the following described real property and premises, situated in Tulsa County, State of Oklahoma, to wit:

A 10 foot easement being 5 feet on either side of line beginning 600 feet West of the Northeast corner of Section 11, Township 18 North, Range 14 East, running thence South 395 feet to the Northerly line of premises owned by the grantee herein,

with right of ingress and egress to and from the same for the purpose of laying, erecting, maintaining and operating over, through and upon the same a water pipe line, with the further right to change the size of such pipe line.

Provided that such pipe line shall be buried at a depth sufficient under the ground that the same will not interfere with the normal use of said premises by the first parties.

Provided further that the grantors herein and their heirs, administrators and assigns, shall be entitled to six 3/4" water taps to service lots along the Northerly side of the NE/4 of the NE/4 of Section 11, Township 18 North, Range 14 East, Tulsa County, Oklahoma, the same to be provided by the grantee herein when requested by the grantors, their heirs, administrators and assigns, and without charge.

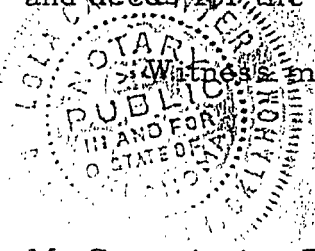
