


NOTES:

- A. EXCAVATION OF COMPENSATORY STORAGE AREA TO ACHIEVE DESIGNED GRADING PLAN.
- B. PLACEMENT OF FILL TO ACHIEVE DESIGN GRADES. COMPENSATORY STORAGE AREA MAY BE EXCAVATED DEEPER TO OBTAIN FILL MATERIAL.
- C. THE COMPENSATORY STORAGE 8-INCH PIPE SHALL BE INSTALLED TO DRAIN COMPENSATORY STORAGE AREA WITH FL. @ 661.5 AT INLET AND AT 661.0 AT OUTLET IN BAR DITCH. IF COMPENSATORY STORAGE AREA IS EXCAVATED DEEPER, OUTLET PIPE FLOWLINES REMAIN THE SAME WITHOUT CHANGES.
- D. AFTER ALL EXCAVATION IS COMPLETED, THE EXPOSED SIDE SLOPES SHALL BE HYDRO-MULCHED AND PROTECTED UNTIL THE GRASS HAS REACHED MATURITY. THIS WILL INCLUDE PERIODIC WATERING.
- E. THE CONTRACTOR SHALL MOBILIZE, DEMOBILIZE AND CLEAN THE AREA OF DISTURBANCE.
- F. ALL ENVIRONMENTAL PERMITS SHALL BE OBTAINED BY THE CONTRACTOR.

- E. THE CONTRACTOR SHALL MOBILIZE, DEMOBILIZE AND CLEAN THE AREA OF DISTURBANCE.
- F. ALL ENVIRONMENTAL PERMITS SHALL BE OBTAINED BY THE CONTRACTOR.


