#### 5. General Authority Business

##### **A. 19-94 Consideration, discussion, and possible approval of and authorization to execute a Second Extension to agreement for the Purchase and Sale of Real Estate by and among the Broken Arrow Economic Development Authority and SoundMind Behavioral Health Hospital, LLC**

Economic Development Manager, Norm Stephens, reported on January 3, 2018, the City approved an Economic Development Agreement with SoundMind, LLC. for the purchase of 14 acres of City owned land at a cost of \$1.2 million dollars, following which SoundMind underwent a PUD to add restrictions with Authority direction. He explained SoundMind was originally scheduled to close by October 2, 2018; however, there were questions from the lending institution about the PUD; Staff met with the lending institution to work through the concerns. He stated SoundMind entered negotiations with Center Point which ran behavioral hospitals in the region; Center Point was now a part of the Certificate of Need. He stated in October an extension was granted until the end of December due to the lending institution; currently, due to the final negotiations between SoundMind and Center Point, an extension of 60 days was requested. He stated Center Point's presentation to Broken Arrow Economic

Development Authority would be moved from the last Meeting in January to the first Meeting in February.
