That all undersigned, RUTH ELIZABETH WOODS, TRUSTEE FOR THE RUTH ELIZABETH WOODS REVOCABLE TRUST, the Owner(s), of the legal and equitable title to the following described real estate situated in TULSA County, State of Oklahoma, for and in consideration of the sum of One Dollar (\$1.00), cash in hand, paid by the City of Broken Arrow, Oklahoma, and other good and valuable considerations, receipt of which are hereby acknowledged, do(es) hereby grant and convey unto the said City of Broken Arrow, County of Tulsa, State of Oklahoma, a temporary easement, through, over, and under, and across the following described property, situated in said County, to-wit:

for a period of not more than 12 MONTHS FROM THE START OF CONSTRUCTION. This grant of temporary right to use and occupy is given for the purpose of permitting the City of Broken Arrow, its employees, representatives, agents, and/or persons under contract with it, to use said described property for construction of street improvements for the Main Street Streetscapes, Phase V, project # ST1820.

That the Owner(s) agree that this temporary construction easement shall be binding upon their heirs, executors, administrators and personal representatives during the term hereof and further agree that in the event the premises covered by this temporary construction easement are sold, assigned or conveyed, that the purchaser or grantee thereof will be advised of the existence of this temporary grant and that said sale during said term shall be made subject to the rights herein given.



LEGAL DESCRIPTION:

A tract of land that is a part of Lots 11, 12 and 13 of Block 19, "ORIGINAL TOWN OF BROKEN ARROW" an addition to the City of Broken Arrow, filed at the office of the Tulsa County Clerk, being a subdivision of part of the West Half (W2) of Section Eleven (11), Township Eighteen (18) North, Range Fourteen (14) East of the Indian Meridian, Tulsa County, State of Oklahoma, according to the United States Government Survey thereof being more particularly described as follows:

Point of Beginning at the Southeast Corner of said Lot 11 of Block 19;  
thence along the East line of said Block 19, N01°10'20"W a distance of 75.00 feet to the Northeast Corner of said Lot 13;  
thence along the North line of said Lot 13, S88°45'04"W a distance of 7.00 feet;  
thence S01°10'20"E a distance of 75.00 feet to the South line of said Lot 11;  
thence N88°45'04"E a distance of 7.00 feet to the Point of Beginning.
