Utilities Director, Chuck Vokes, reported in the last couple of years the Broken Arrow Water Treatment Facility received concerns regarding the taste and odor of the water. He explained the reasons for the taste and odor were naturally occurring compounds found seasonally in algae worldwide. He stated the Agreement with HDR Engineering, Inc. was designed to test several of the best available technologies: powder activated carbon, granular activated carbon, ozonation, and bio-filtration. He stated the study would take approximately eight months, included coordination with the Oklahoma Environmental Department and would result in a summary report of recommendations.

Council Member Wimpee indicated she appreciated Mr. Vokes noting the problem was not just in Broken Arrow. She stated she looked forward to viewing the results of the study.
