Work performed under the contract shall be lump sum and any additional services requested by the City shall be performed on an hourly basis in accordance with the attached hourly rates.

- a.1. Right of Way and Control/Topographic Survey – **Lump Sum amount of Four Thousand Eight Hundred Fifty Dollars (\$4,850.00).**
- a.2. Legal Descriptions, Field and Stake Legal Descriptions – **Unit Price of \$250.00 per legal description to prepare the legal description as needed and only as directed and authorized by the City, and the Unit Price of \$225.00 per legal description to field pin and stake the legal description as needed and only as directed and authorized by the City. Four legal descriptions are estimated into this contract at the Lump Sum of One Thousand Nine Hundred Dollars (\$1,900.00).**
- a.3. Total Contract Amount – **Six Thousand Seven Hundred Fifty Dollars (\$6,750.00).**
- b. Liquidated Damages: N/A.
- c. The total time allowed for contract completion is 30 calendar days.

The City of Broken Arrow and Geodeca, LLC, with its principal place of business located at P.O. Box 330281, Tulsa, OK 74133, hereby enters into the following Contract:

The Assistant City Manager, representing the City of Broken Arrow, is contracting to acquire the professional services of the Consultant to provide Surveying and related support services associated with public work projects. Professional Surveying services to include site surveying, legal description and exhibit preparation, and other surveying services as needed by the City.

The Consultant shall perform all duties, responsibilities and requirements set out in the Professional Services Contract Special Provisions Attachment, attached hereto and made a part hereof.

These duties, responsibilities and requirements shall begin upon the execution of this Contract and shall be completed within Thirty (30) calendar days.

The basis of compensation for the Consultant to perform all duties and responsibilities associated with the Scope of Services described in the Special Provisions Shall be in accordance with the following:

Right of Way and Control/Topographic Survey: The OWNER shall pay the CONSULTANT a lump sum amount of \$4,850.00 for the completion of the Right-of-Way and Control and the Topographic Survey. This amount includes all labor, material, overhead and profit associated with the Scope of Services.

Legal Descriptions, Field Pin and Stake Legal Descriptions: The OWNER shall pay the CONSULTANT, as directed and authorized by the OWNER, \$250.00 per legal description to prepare legal descriptions, and \$225.00 per legal description to field pin and stake the legal description. Four legal descriptions are estimated into this contract at the lump sum amount of \$1,900.00. This amount includes all labor, material, overhead and profit associated with the Scope of Services.

The City will issue a Notice to Proceed for the work identified under this agreement. The Consultant shall submit invoices requesting payment for services rendered to the City monthly in accordance with actual progress of the work on each work item. The invoices shall be in a format satisfactory to the City. Payment will be made following the first eligible City Council meeting occurring after the date on the invoice.

The Consultant agrees that this professional service shall be treated as an important service to the City and also agrees to commit the time necessary to perform the professional services in a professional manner.

The parties agree that the Consultant's position is not a traditional City employee position; therefore the foregoing constitutes all the benefits and other forms of compensation due

the Consultant, acting in the role of an independent contractor, and therefore ineligible for all other benefits paid to regular full-time City employees. The Consultant agrees to abide by and comply with all of the City's Administrative Policies.

The Consultant shall acquire all insurance policies required for professional liability insurance, auto insurance, and/or health insurance. The Consultant shall be responsible for his own vehicle expenses and any other indirect costs incurred in fulfilling the stated contract requirements.

The foregoing Professional Services Contract supersedes all previous negotiations and may not be modified except by a written order executed by the parties hereto.

**SPECIAL PROVISIONS
PROJECT NUMBER ST1945**

SP - 1.0 SCOPE OF THE PROJECT:

1.1. This project will consist of a survey of the alley between Ash Avenue and Main Street, from south side of Dallas Street to the north side of College Street. The survey will be from building face to building face and include a full topographic survey and also include establishing right of way and control, including all easements, writing legal descriptions, field pinning and staking of legal descriptions.

SP - 2.0 SERVICES OF THE CITY: THE CITY WILL:

2.1. Furnish to Consultant all data in its possession, and needed engineering guidance as necessary for the service provider to complete the contract requirements.

2.2. Designate in writing a person to act as its representative in respect to the work to be performed under this agreement. Such person shall have complete authority to transmit instructions, receive information, interpret and define the City's policies and decisions with respect to materials, equipment, elements and systems pertinent to the services covered by this agreement.

SP -3.0 SCOPE OF SERVICES: THE CONSULTANT SHALL:

3.1 The Consultant shall provide Professional Surveying services as outlined in the attached proposal.

3.2 The consultant shall submit, in-full, the survey on electronic media (AutoCAD 2018 or earlier version), a Digital Terrain Model, a pdf of the final signed/sealed survey.

3.3 The consultant shall submit, in-full, legal descriptions and field pin and stake the legal descriptions, 4 parcels are estimated. These are only to be done as directed and authorized by the City.

Scope: Establish property and alley lines with topographic survey.

Fee: \$4850

Right of Way and Control: Establish right of way and control to include easements as known by either a search using the Tulsa County online records search "ONCORE" or from property reports prepared by others. (If needed property reports are \$250 per report.)

Topographic survey: To include the location of buildings or portions of, large structures, paved areas, public utilities visible and marked, large storm water drainage systems and structures as practicable, finished floors, and stoops. Digital Terrain Model with 1 foot contours.

Additional Legal Descriptions: \$250 each as needed (only as directed and authorized by Engineer)

Field Pin and Stake Legal Descriptions: \$225 per Legal Description: as needed.

Field data when appropriate will be in U.S. Survey feet translated and rotated to Ok State Plane North Horizontal datum (all distances will be ground distances), or translated and rotated to adjoiners or existing legal descriptions. Vertical Datum will be North American Vertical Datum of 1988 (NAVD 88).
