This quote is being provided to replace s/n 1783 (GZ) with latest Deli server planform and latest HindSight G3 platform and add NAS storage for backup. Recorder to be configured as follows:

80 total channels

- transfer 24 analog channels for Vesta analog positions and analog phones (existing 24 channel line card will be re-used)
- transfer 16 Cisco VoiP channels
- transfer 24 P25 radio channels
- add additional 16 P25 radio channels (for a total of 40 P25 channels)

7 Timegate licenses to be renewed to G3

This quote assumes all wiring will be delivered to the Execom recorder location, including the Cisco VolP network.

The City will need to consolidate existing analog source lines from punch-down block to one cable to one line card.

3 TB RAID 5 storage backup (NAS) solution is included. There is currently no backup system in place.
