5. Public Hearings, Appeals, Presentations, Recognitions, Awards

A. 19-874 Presentation on the County Line Trunk Sewer Improvement Project

Assistant City Manager of Operations Kenny Schwab reported on June 3, 2019, the Broken Arrow Municipal Authority approved and authorized the execution of a public construction contract for Phase I of the County Line trunk sewer to Belt Construction, Inc. in the amount of just over \$16 million dollars. He stated the City of Broken Arrow had two waste product treatment plants: Haikey Creek (which was shared with other municipalities) and the Lynn Lane Wastewater Treatment Plant. He gave a brief history of the disposal treatment plants in the City of Broken Arrow. Mr. Schwab noted there would be two phases of construction from the Lynn Lane Wastewater Treatment Plant going north along County Line to Washington (91st Street). He stated there were two branches of trunk sewers which drained to Lynn Lane and the 1985 County Line Road trunk sewer line was the newest of the sewer lines by 15 years, yet was in the worst condition. He explained this was due to the usage of concrete materials; the County Line trunk sewer was constructed of concrete pipe and over the years experienced severe pipe deterioration and degradation. He explained the sewer gases has deteriorated the top of the concrete pipe material to the point where much of the material had broken off and fallen into the sewer. He stated there had been three emergency declarations since April 22, 2016 regarding the County Line Trunk Sewer. He displayed and discussed pictures which illustrated sewer line construction and deteriorated concrete pipes. He displayed and discussed a map which illustrated Phase I and Phase II of the County Line trunk sewer project. He stated Phase I extended three and a half miles, consisted of use of a 60 inch diameter pipe, 54 inch diameter pipe, and 48 inch diameter pipe. He noted the existing concrete pipe was roughly 27 inches in diameter. He discussed various pipe materials and noted the new pipeline would be PVC material. He stated Belt Construction was a large contractor and very skilled in this type of work; the project would take approximately 510 days.

Trustee Parks asked if any housing divisions were tapped into the County Line trunk sewer line. Mr. Schwab responded in the negative; he did not believe so, but he was not certain. Trustee Parks asked how Belt performed in the emergency situations. Mr. Schwab responded Belt performed excellently in the emergency situations, used the proper equipment and staged the repairs very well.

City Manager Spurgeon noted this was a major investment and as such he felt it was important to keep the Authority aware of how the project was progressing.
