- 2.0 <u>COMPENSATION</u>. The AUTHORITY and the ENGINEER agree that the ENGINEER shall be compensated for these additional services on a salary multiplier basis in accordance with Attachment D-1, <u>COMPENSATION FOR ADDITIONAL SERVICES</u>, which is attached hereto and incorporated by reference as part of this AMENDMENT NO. 1.
- 3.0 All other terms and conditions of the AGREEMENT of October 7, 2016 as amended, shall remain in full force and effect.

SCOPE OF SERVICES

ATTACHMENT B-1

- B. SCOPE OF SERVICES. The Scope of Services shall be amended as follows:
 - B.1. The ENGINEER shall provide services during construction (SDC) during the anticipated 21-month construction period, including technical interpretations of the drawings, specifications, and Contract Documents, evaluation of requested deviations from the approved design or specifications, and response to Contractor questions. Appropriate documentation will be accomplished through the use of a Request for Information (RFI) form.
 - B.2. ENGINEER Project Manager will lead and participate in a Preconstruction Conference to assist in implementing the construction process and distribute ten (10) half sized sets of conformed plans that incorporate all addendum items.
 - B.3. Assist onsite Resident Project Representative in preparation and/or review of field orders and change orders as needed to provide for construction. Issues involving potential modification of the design, contract dollars or time will be documented through the use of a Contract Modification Request (CMR) form.
 - B.4. Review Contractor submittals, consisting of payment requests, shop drawings, diagrams, illustrations, catalog data, schedules and samples, the results of tests and inspections, and other data that the Contractor is required to submit. Submittal review shall be for general conformance with the design concept of the Project and general compliance with the information given in the Contract Documents. The extent of the ENGINEER's review shall be as defined in the General Conditions of the Contract Documents.
 - B.5. Attend monthly construction meetings including a site visit to determine if, in general, the construction is proceeding in accordance with the Contract Documents. It is understood that this assistance does not relieve the Construction Contractor from his full responsibility for constructing the work in accordance with the Contract Documents.
 - B.6. Assist the AUTHORITY in negotiating final payment for construction.

- B.7. Review Contractor's construction schedule on a monthly basis.
- B.8. Prepare for the AUTHORITY a set of record drawings suitable for microfilming showing those changes made during the construction process based on marked-up prints, drawings and other data furnished by the Contractor and the RPR to the ENGINEER, such information being required of the Contractor in the Construction Contract Documents. Record drawings shall be prepared on the original Project Mylars or a scanned version thereof. The ENGINEER shall also submit digital files of the record drawings in a format compatible with MicroStation Version 8.0 including all font and reference files. ENGINEER is not responsible for any errors or omissions in the information from others that is incorporated into the record drawings.
- B.9. Provide Special Inspection in accordance with Chapter 17 of the 2015 International Building Code with an approved Special Inspector.
- B.10. Provide laboratory material testing.
- B.11. ENGINEER agrees to provide these services for a period of time estimated to equal the 21-month construction contract duration of the project.

SDC Disclaimer:

1. Consultant's Personnel at Construction Site

The presence or duties of ENGINEER's personnel at a construction site, whether as onsite representatives or otherwise, do not make ENGINEER or ENGINEER's personnel in any way responsible for those duties that belong to the AUTHORITY and/or the construction contractors or other entities, and do not relieve the construction contractors or any other entity of their obligations, duties, and responsibilities, including, but not limited to, all construction methods, means, techniques, sequences, and procedures necessary for coordinating and completing all portions of the construction work in accordance with the construction Contract Documents and any health or safety precautions required by such construction work.

ENGINEER and ENGINEER's personnel have no authority to exercise any control over any construction contractor or other entity or their employees in connection with their work or any health or safety precautions and have no duty for inspecting, noting, observing, correcting, or reporting on health or safety deficiencies of the construction contractor(s) or other entity or any other persons at the site except ENGINEER's own personnel.



ENGINEER neither guarantees the performance of the construction contractor(s) nor assumes responsibility for construction contractor's failure to perform work in accordance with the construction documents.


2. ENGINEER and design team's review of all shop drawings, samples and submittals shall be for general conformance with the design concept and general compliance with the requirements of the contract for construction. Such review shall not relieve the Contractor from its

responsibility for performance in accordance with the contract for construction, nor is such review a guarantee that the work covered by the shop drawings, samples and submittals is free of errors, inconsistencies or omissions.

3. Construction Progress Payments

Recommendations by ENGINEER to the AUTHORITY for periodic construction progress payments to the construction contractor(s) will be based on ENGINEER's knowledge, information, and belief from selective sampling that the work has progressed to the point indicated. Such recommendations do not represent that continuous or detailed examinations have been made by ENGINEER to ascertain that the construction contractor(s) have completed the work in exact accordance with the construction documents; that the final work will be acceptable in all respects; that ENGINEER has made an examination to ascertain how or for what purpose the construction contractor(s) have used the moneys paid; that title to any of the work, materials, or equipment has passed to the AUTHORITY free and clear of liens, claims, security interests, or encumbrances; or that there are not other matters at issue between the AUTHORITY and the construction contractors that affect the amount that should be paid.

This service shall be performed on a T&M basis with \$100,800 (including subcontractor 5% markup) as allowance for the task.
