## **ORDINANCE NO. 3616**

An ordinance amending the zoning ordinance of the City of Broken Arrow, Oklahoma, approving BAZ-1975, generally located one-half mile west of Evans Road (225<sup>th</sup> E. Avenue), south of Kenosha Street (71<sup>st</sup> Street), granting a IL zoning classification be placed upon the tract along with PUD-259, repealing all ordinances or parts of ordinances in conflict herewith, and declaring an emergency

WHEREAS, the State of Oklahoma has granted cities, as governmental entities, the duty and power to enact zoning ordinances for the protection of persons and property residing within the City limits, and for securing the benefits of orderly development as a whole; and

WHEREAS, rezoning case BAZ-1975 (A-1 to IL) and PUD-259 were approved by the Broken Arrow City Council on April 4, 2017, subject to the property being platted; and

WHEREAS, the property has been platted as Timber Ridge Business Park. The plat for Timber Ridge Business Park, which contains 72.02 acres, was recorded in Wagoner County on May 17, 2019; and

WHEREAS, the property associated with Timber Ridge Business Park is generally located one-half mile west of Evans Road (225<sup>th</sup> E. Avenue), south of Kenosha Street (71st Street), Broken Arrow, Oklahoma; and

WHEREAS, the proposed zoning is compatible with the comprehensive plan and surrounding uses; and

WHEREAS, the granting of the application will not have an adverse effect on the other property in the area or in the community; and

WHEREAS, for these reasons, the City Council finds this request should be granted.

## BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROKEN ARROW, OKLAHOMA:

**SECTION I.** The zoning classification of the following described real estate situated in Tulsa County, State of Oklahoma, being more particularly described as follows:

All of Timber Ridge Business Park, a subdivision in the City of Broken Arrow, being a part of the W/2 of Section 8, Township 18 North, Range 15 East, of the Indian Meridian, Wagoner County, State of Oklahoma, document number 2019-5980.

be and the same is hereby changed from the zoning A-1 (Agricultural) to IL (Industrial Light), along with PUD-259.

**SECTION II.** Any ordinance or parts of ordinances found to be in conflict herewith are hereby repealed.

**SECTION III.** An emergency exists for the preservation of the public health, peace, and safety, and therefore this ordinance shall become effective from and after the time of its passage and approval.
