RIGHT-OF-WAY DEDICATION LEGAL DESCRIPTION:

A TRACT OF LAND THAT IS PART OF LOT ONE (1), BLOCK ONE (1), S.K.K. CENTER, AN ADDITION TO THE CITY OF BROKEN ARROW, WAGONER COUNTY, STATE OF OKLAHOMA, ACCORDING TO THE RECORDED PLAT THEREOF, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHWEST CORNER OF SAID LOT 1, BLOCK 1:

THENCE NORTH 00°00'00" EAST ALONG THE WEST LINE THEREOF 124.87 FEET TO A POINT OF CURVATURE:

THENCE NORTHEASTERLY ALONG A CURVE TO THE RIGHT HAVING A RADIUS OF 35,00 FEET, AN ARC LENGTH OF 55.11 FEET. A CHORD BEARING OF NORTH 45°06'32" EAST AND A CHORD LENGTH OF 49,59 FEET:

THENCE SOUTH 89°46'57" EAST 139.87 FEET TO THE NORTHEAST CORNER OF SAID LOT 1:

THENCE SOUTH 00°00'00" WEST ALONG THE EAST LINE OF LOT 1 A DISTANCE OF 15.00 FEET;

THENCE NORTH 89°46'57" WEST AND PARALLEL TO THE NORTH LINE OF LOT 1 A DISTANCE OF 145.00 FEET;

THENCE SOUTH 45°06'31" WEST 35.29 FEET;

THENCE SOUTH 00°00'00" WEST AND PARALLEL TO THE WEST LINE OF LOT 1 A DISTANCE OF 120.00 FEET TO THE SOUTH LINE OF LOT 1;

THENCE NORTH 89°46'57" WEST ALONG SAID SOUTH LINE A DISTANCE OF 5.00 FEET TO THE POINT OF BEGINNING.
