

RESOLUTION NO. 1323

A RESOLUTION OF THE BROKEN ARROW CITY COUNCIL CHANGING THE DATE OF THE REGULARLY SCHEDULED MEETINGS OF THE BROKEN ARROW CITY COUNCIL, BROKEN ARROW ECONOMIC DEVELOPMENT AUTHORITY AND BROKEN ARROW MUNICIPAL AUTHORITY ON JUNE 1, 2020 AND JUNE 15, 2020 TO THE NEW DATE OF TUESDAY, JUNE 2, 2020 AND TUESDAY, JUNE 16, 2020 AT 6:30 P.M. DUE TO THE CANCELLATION OF TUESDAYS IN THE PARK

WHEREAS, by December 15, 2019, notice of the regularly scheduled meetings of the Broken Arrow City Council, Broken Arrow Economic Development Authority and Broken Arrow Municipal Authority were given to the public as regularly scheduled meetings; and

WHEREAS, City meetings are normally scheduled on the first and third Tuesday of every month; and

WHEREAS, the Broken Arrow City Council, Broken Arrow Economic Development Authority and Broken Arrow Municipal Authority meetings were originally set for Monday, June 1, 2020 and Monday, June 15, 2020, to accommodate for Tuesdays in the Park; and

WHEREAS, the COVID-19 pandemic has forced the cancellation of Tuesdays in the Park for June 2020; and

WHEREAS, if a change in meeting date, time or place occurs, written notice shall be given to the Municipal Clerk at least ten (10) days prior to the implementation of said change; and

WHEREAS, the City Council desires to have the Broken Arrow City Council, Broken Arrow Economic Development Authority and Broken Arrow Municipal Authority meetings set on Tuesday, June 2, 2020 and Tuesday, June 16, 2020 beginning at 6:30 p.m.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BROKEN ARROW, OKLAHOMA, THAT:

1. That the Broken Arrow City Council, Broken Arrow Economic Development Authority and the Broken Arrow Municipal Authority meetings previously set for June 1, 2020 and June 15, 2020 shall be and are hereby changed to Tuesday, June 2, 2020, beginning at 6:30 p.m. and Tuesday, June 16, 2020, beginning at 6:30 p.m.


