THIS **AMENDMENT NO. 1**, made and entered into this 19th day of May 2020, by and between the CITY OF BROKEN ARROW, OKLAHOMA, a municipal corporation of the State of Oklahoma, hereinafter referred to as "CITY", and A&A Asphalt, Inc., hereinafter referred to as "CONTRACTOR";

WITNESSETH:

WHEREAS, CITY and CONTRACTOR entered into an Agreement dated May 7, 2019 "ORIGINAL AGREEMENT" for services as set forth in said Agreement; and

WHEREAS, said ORIGINAL AGREEMENT requires CONTRACTOR to provide asphalt milling services for the various milling jobs associated with resurfacing projects.

WHEREAS, CITY and CONTRACTOR propose to amend said ORIGINAL AGREEMENT to renew the contract for an additional year at the same unit prices.

WHEREAS, the ORIGINAL AGREEMENT and Amendment No. 1 shall hereinafter collectively be referred to as the "Agreement"; and

WHEREAS, funding is now available for said additional services; and

WHEREAS, CONTRACTOR is prepared to provide said additional services identified in this Amendment.

NOW THEREFORE, in consideration of the promises contained herein, the parties hereto agree to amend the Agreement as follows:

1. PROJECT SCOPE.

This Amendment requires CONTRACTOR to provide cold milling of asphalt streets at various locations, within the corporate limits of the City of Broken Arrow and it is to be accomplished by a non-encumbered contract utilizing the unit price per square yard per approved bid no. 19.158.

2. CHANGE IN CONTRACT AMOUNT.

As compensation for the additional work, CITY shall pay CONTRACTOR in accordance with the terms as a change in the contract amount;

If CONTRACTOR signs this AMENDMENT electronically and/or submits documents electronically, CONTRACTOR agrees to comply with OWNER'S requirements for submission of electronically signed and/or submitted documents.

Except as amended hereby, all terms of the Agreement shall remain in full force and effect without modification or change.
