

EASEMENT CLOSURE LEGAL DESCRIPTION

A TRACT OF LAND WHOLLY CONTAINED WITHIN LOT FOURTEEN (14), BLOCK ONE (1) OF WAKEFIELD HEIGHTS AT BATTLE CREEK, AN ADDITION TO THE CITY OF BROKEN ARROW, TULSA COUNTY, STATE OF OKLAHOMA, ACCORDING TO THE RECORDED PLAT NO. 5177, AND MORE PARTICULARLY DESCRIBED AS FOLLOWS, TO-WIT:

COMMENCING AT THE SOUTHEASTERLY CORNER OF SAID LOT FOURTEEN (14) BLOCK (1), THENCE N 41°47'34" W ALONG THE NORTHEASTERLY LINE OF SAID LOT FOURTEEN (14) A DISTANCE OF 11.00 FEET TO THE POINT OF BEGINNING; THENCE CONTINUING N 41°47'34" W A DISTANCE OF 4.00 FEET; THENCE S 46°18'00" W A DISTANCE OF 69.33 FEET; THENCE S 58°23'45" E A DISTANCE OF 4.13 FEET; THENCE N 46°18'00" E A DISTANCE OF 68.15 FEET TO THE POINT OF BEGINNING.
