WHEREAS, OWNER and ARCHITECT entered into an Agreement dated February 19, 2019 for services as set forth in said Agreement; and

WHEREAS, said Agreement requires ARCHITECT to prepare construction documents for bidding purposes for the construction of Senior Citizen's Activity Center and

WHEREAS, OWNER and ARCHITECT propose to amend said Agreement to expand the project scope and compensation; and

WHEREAS, funding is now available for said additional services; and

WHEREAS, ARCHITECT is prepared to provide said additional services identified in this Amendment.

NOW THEREFORE, in consideration of the promises contained herein, the parties hereto agree to amend the Agreement as follows:

1. PROJECT SCOPE.

This Amendment requires ARCHITECT will work with The City of Broken Arrow to provide a fire hydrant flow test and preliminary design services for the audio/video rough-in requirements needed to be located Senior Citizen's Activity Center.

2. SCOPE OF ARCHITECT SERVICES

a. The ARCHITECT will order a fire hydrant flow test to be preformed and summit the results to the Broken Arrow fire marshal. The cost shall be a fixed fee of \$200.

b. The ARCHITECT will add the additional information to the plans and specifications to prepare the Senior Citizen's Activity Center to accept the audio/video equipment that is anticipated in a facility of the type. The cost shall be a fixed fee of \$5,600.00.

3. CHANGE IN CONTRACT AMOUNT.

As compensation for the additional work, OWNER shall pay ARCHITECT in accordance with the change in the contract amount;
