# A. 19-1402 Cons

Consideration, discussion, and possible approval of and authorization to execute an Economic Development Agreement between the Broken Arrow Economic Development Authority, an Oklahoma Public Trust (together with its successors and assigns, "BAEDA") and the Broken Arrow Municipal Authority (together with its successors and assigns, "BAMA"), Collectively the "City", and DHTC Development, LLC ("DHTC"), for an affordable senior housing project to be located near 37th and Kenosha Street in Broken Arrow

Economic Development Coordinator Norm Stephens reported DHTC Development, LLC specialized in providing seniors and families with better living since 2008; DHTC had been a part of and developed over 750 units of single family and multi-family housing. He reported Debra Shantz Hart and Tammi Creason were the principle owners of DHTC Development. LLC. He noted recently DHTC leadership approached Broken Arrow City Manager Michael Spurgeon requesting to enter into a Public / Private Partnership to build affordable senior housing in the area of 37th and Kenosha Street, in the City of Broken Arrow, County of Wagoner, to be named Timber Ridge Cottages. He stated Mr. Riley Shantz and Ms. Debra Hart were present to give a brief project overview.

Ms. Debra Hart with DHTC stated she began this process two years ago and in May of 2019 received an allocation of tax credits for a 74-unit development which would be a combination of 28 apartment units with an additional 46 units designed as 4-plex to duplex units with attached garages. She stated she felt this was an excellent stimulus for the senior community. She noted this area was slated for road improvements and this extension of sewer would open up more development land in the area. She displayed and discussed an illustration of the apartment building design (contemporary farmhouse).

Vice Chairperson Eudey asked if there was a restricted covenant associated with this development or if the PUD required the development perpetually be used for senior living. Ms. Hart indicated DHTC used a Land Use Restriction Agreement which would require this development to be used for senior housing for 30 years.

City Manager Spurgeon stated he was excited about this development. He noted Staff submitted a letter of recommendation in support of the project to the Oklahoma Housing Finance Agency and received funds and tax credits which was a sure indication the development would be high quality and a good investment. He stated he recommended partnering with DHTC regarding sewer and road improvements for the project.

Vice Chairperson Eudey noted as he served as Vice President of the Board of Directors for the Church which adjoined this property, he would abstain from the vote.

Trustee Gillespie asked if the development would be on the east or west side of the Turnpike. Ms. Hart responded the development would be on the west side of the Turnpike.
