He noted that the property had been previously appraised at \$1.3 million. He indicated that Carr Healthcare Realty, on behalf of Dr. Drew Endicott, has stated an interest in the property, and he recommended that City Council authorize the sale of the property to Dr. Endicott in the sum of \$416,000 and approve

Resolution No. 1215.
