BACP-183 is a request to change the Comprehensive Plan designation on an approximately 17.25-acre tract of land. The applicant has requested to change from Level 3 (Transition Area) to Level 4

(Commercial/Employment Nodes) to facilitate the redevelopment of a portion of the property for a commercial area. The property is developed as Core Church of the Nazarene and was platted in the City of Broken Arrow as Core Church at Aspen Creek on November 26, 2014.

The property has an underlying zoning of ON (Office Neighborhood) which permits the current place of assembly use by right. The Level 4 comprehensive plan designation being requested permits ON as an allowed zoning district in Level 4. Therefore, changing the comprehensive plan designation will not negatively affect the current use of the property.
