Background:

The attached General Warranty Deed, Utility Easement, and Temporary Construction Easement conveyed to the City of Broken Arrow from Christopher A. and Deborah M. Brown, husband and wife.

Damages: \$3,250.00
Total Compensation Amount (Rounded): \$ 10,800.00
