## **Background:**

The right-of-way acquisition for the Washington Street: Olive to Garnett, widening project has been approved for funding in the General Obligation Bond 2014. The City's right-of-way agent has attempted unsuccessfully to negotiate with Nghi Uy Troung and Diem Thuy Khoa Nguyen, for Parcel 19, 19a, generally located one parcel east of 11520 E 91<sup>st</sup> Street So. Section 20, Township 18 North, Range 14 East. The attached Resolution of Necessity No. 1159 recommends that condemnation proceed on Parcel 19 and 19a for Fee Simple Permanent Right-of-Way and a Temporary Construction Easement.

**Cost:** To be determined by Commissioners (Est. at \$1,320 plus court costs)
