Background:

The attached Permanent Easement and Temporary Construction Easement are being conveyed to the City of Broken Arrow, a municipal corporation, from the Ray G. Medlock Trust, the owner. Ray G. Medlock has accepted the offer of \$25,050.00, subject to City Council approval.

Permanent Easement: 15,217.76 SQUARE FEET (SF) @ \$1.50 SF x 75% = \$17,119.98Temporary Construction Easement: 15.1 Rental Period until 12/31/2020 26,400.04 SF @ \$1.50 SF x 20% = \$7,920.01Total Just Compensation Amount (Rounded) = \$25,050.00

A copy of the signed acceptance of the City's offer is attached, as are the Easements. Payment of the compensation amount is on the January 2, 2019 City Council Claims List.
