Background:

The attached Temporary Construction Easements are being conveyed to the City of Broken Arrow from KAM LLC, an Oklahoma limited liability company, the owner. Parcel 9.1 consists of .64 acres and Parcel 9.2 consists of 1.20 acres of Temporary Construction Easements for the County Line Trunk Sewer Replacement, located in the Northwest Quarter of Section 1, Township 17 North, Range 14 East, Tulsa County, State of Oklahoma. KAM LLC has accepted the following offer, made subject to City Council approval:

Temporary Construction Easement: 9.1 and 9.2 Rental Period until 12/31/2020

80,159.45 SF @ \$ 0.15 SF x 20% = \$2,392.27

Total Just Compensation Amount (Rounded) = \$2,400.00
