Background:

BAZ-2017 (R-1 to ON, along with the abrogation of SP-74 and SP-74A), which involved a 5.12 acre parcel, were approved by the Broken Arrow City Council on January 15, 2019. Platting was waived. The property associated with International Christian Assembly of Tulsa is located north of Houston Street (81st Street), one-half mile east of Garnett Road (113th E. Avenue).

Staff recommends that the Council adopt Ordinance No. 3625 and approve the Emergency Clause.

Zoning Change: R-1 (Single-Family Residential) to ON (Office Neighborhood)

Acreage: 5.12 acres

Legal description

A tract of land located in Lot One (1), Block One (1), "Forest Hills Heath Care Center" an Addition of the City of Broken Arrow, Tulsa County, State of Oklahoma, according to the official recorded plat thereof, Plat No.

5215, as filed in the records of the Tulsa County Clerk's office, being more particularly described as follows:

Beginning at the Southeast corner of Lot 1, Block 1, "Forest Hills Health Care Center"; Thence south 89° 49'41" West along the South line of Lot 1, Block 1, "Forest Hills Health Care Center" a distance of 200.00 feet; Thence North 00°00'55" West a distance of 50.00 feet; Thence North 89°49'41" East and parallel with the South line of Lot 1, Block 1, "Forest Hills Health Care Center" a distance of 106.24 feet; Thence North 00°00'55" West a distance of 320.88 feet; Thence North 31°40'37" West a distance of 65.34 feet; Thence North 00°00'55" West a distance of 198.41 feet; Thence South 89°59'05" West a distance of 87.66 feet; Thence North 21°40'19" West a distance of 77.67 feet to the Northerly line of Lot 1, Block 1 "Forest Hills Health Care Center"; Thence North 68°19'41" East along the Northerly line of Lot 1, Block 1, "Forest Hills Health Care Center" a distance 302.98 feet; Thence South 53°06'00" East along the Northerly line Lot 1, Block 1, "Forest Hills Health Care Center" a distance of 430.59 feet to the most Easterly corner of Lot 1, Block 1, "Forest Hills Health Care Center"; Thence South 45°00'00" West along the Northerly line of Lot 2, Block 1, "Forest Hills Health Care Center" a distance of 335.20 feet; Thence South 89°49'35" West along the Northerly line of Lot 2, Block 1, "Forest Hills Health Care Center" a distance of 144.40 of the most Westerly Northwest corner of Lot 2, Block 1, "Forest Hills Health Care Center"; Thence South 00°00'55" East along the West line of Lot 2, Block 1, "Forest Hills Health Care Center" a distance of 312.66 feet to the "Point of Beginning".
