#### Background:

The Oklahoma Municipal Assurance Group (OMAG) is a provider of General Liability, Auto, Workers' Compensation, Property and Risk Management services for Oklahoma cities and towns since 1977. It is governed by a seven-member Board nominated and elected by its members. The City has been a member of OMAG since 1982. The terms of three trustees expire on June 30, 2020. Thirteen individuals are nominated to fill the three vacancies. After a review of the biographical summary, staff recommends that the ballot be cast for Pam Polk, City Manager, City of Collinsville; Tim Lyon, City Manager, City of Midwest City; and Kim Peterson, Vice-Mayor, City of Poteau.
